Sealed quotations are invited from the interested Medicine Stoers/Firms with valid Registration No./License No. to provide RSBY Medicines at 10% extra over the purchase price including all taxes as per the guideline. All the bidders who have applied earlier require applying a fresh. The sealed quotations should reach to O/O Superintendent, SDH, Bonai by registered post only with valid documents. The quotations should reach to the office on or before 12:00 Noon of 04/05/2018 by Regd. post/Speed Post/Courier and the same will be opened on 05.05.2018 at 11:00 AM. All quotationers are requested to remain present at the time of opening of the quotation. For more details please contact with the undersigned.

Terms & Conditions as per RSBY guideline

1. The medicine shop/firm should reside within 200 meters radius from the hospital.
2. The medicines store/firm should have valid license under Drugs & cosmetic Act., **a copy of which must be submitted along with the tender.**
3. The medicines will be purchased with rate of 10% extra over the purchase price of the drug but it should not exceed the MRP. **The Bidders are requested to clearly mention the exact % age of discount on purchase of medicine in the paper.**
4. The medicine store/Firm must have drugs not less than 75% of commonly prescribed medicine of the hospital. **The Bidders are requested to give a statement of % age of availability of commonly prescribed medicine in their store.**
5. If any medicine to be procured is not available in the medicine store, it will be the responsibility of the store/firm to arrange it and supply within due time.
6. Each quotationer should submit a BD of Rs. 10000/- (Rupees Ten thousand) only drawn in favour of undersigned (non interest bearing incase of unacceptance of bid) from a nationalized bank as EMD. The unsuccessful bidders shall be returned the EMD within one month of the selection of the Agency and the successful bidder shall be returned the EMD after deposit of the Security money 10% of the annual contract.
