



TERMS & CONDITIONS FOR SUPPLY/FITTING OF ASSISTIVE DEVICES TO
PWDS:

1. The tender applicant organisation must have minimum 5 years of experience in supplying Aids/Appliances to PwDs under BBSA & ADIP. Govt. letter/ sanction letter should be attached as a proof with the tender application.
2. An amount of Rs.25,000/- (Rupees Twenty Five Thousand) only should be submitted with tender paper towards EMD amount in shape of TDR from any Nationalised Bank/NSC duly pledged in favour of Collector, Sundargarh..
3. The EMD deposited by the Tenderers will be kept as security deposit and refunded only after finalization of the Tender. Any, participating NGO, if selected, but denies to supply/fitting the order or violets any of the terms and conditions or could not supply/fitting the assistive devices, its EMD will be forfeited and will not be returned back. The EMD of selected supplier will be refunded after audit of accounts.
4. The following documents should be submitted along with the tender Paper failing which their tender application will be rejected and will not be taken into consideration.
 - a. Attested copies of Society Registration Certificate and Bye law in case of Society and Trust deed along with Certificate in case of Trust.
 - b. Attested copy of valid PwD registration certificate.
 - c. EMD in shape of TDR/NSC amounting to Rs.25,000/-..
 - d. Attested copy of PAN card of the NGO.
5. The tender paper will be received only by Registered/Speed Post only addressed to the District Social Security Officer, Collectorate, Sundargarh, Pin-770001 and in no circumstances the hand delivery will be accepted.
6. The sealed envelope containing tender paper must superscribed "Tender for supply/fitting assistive devices to PwDs".
7. The undersigned reserves right to cancel or modify the tender call notice without assigning any reason thereof.
8. The successful tenderer has to supply/fitting the assistive devices at the BBSA camps/Mega Camp(s) which is to be held shortly.
9. Rate quoted per unit of items must be including all Govt. tax/duties if any along with transportation cost to the camp venue.
10. Payment will be made through Cheque/Draft/ NEFT/RTGS only after successful Supply/fitting at the camp site.
11. Any Govt. Tax/GST as applicable will be deducted at source.
12. The Authority also reserves right to negotiate with the tenderer on quoted rates.
