## **SUNDARGARH DISTRICT AT A GLANCE:**

Sundargarh District was constituted on the 1st January, 1948, out of the two ex–States of Gangpur and Bonai, which merged with Odisha on that day. True to its name, this beautiful District of Sundargarh with about 43 percent of its total area under forest cover and numerous colourful tribes dotting its landscape and with abundant mining potential is bounded by Ranchi District of Jharkhand on the North, Raigarh District of Chhatisgarh on the west and North West, Jharsuguda, Sambalpur and Angul Districts of Odisha on the South and South East and Singhbhum District of Jharkhand and Keonjhar District of Odisha on the east.

The Sundargarh town is the district headquarter. Geographically, the district is not a compact unit and consists of widely dissimilar tracts of expansive and fairly open, dotted with tree, clad isolated peaks, vast inaccessible forests, extensive river valleys and mountainous terrain. Broadly speaking, it is an undulating tableland of different elevations broken up by rugged hill ranges and cut up by torrential hill streams and the rivers IB and Brahmani. The general slope of the District is from north to south. Because of this undulating, hilly and sloping nature of landscape, the area is subjected to rapid runoff leading not only to soil erosion but also to scarcity of water for both agriculture and drinking purposes. Brahmani, Sankh, Koel and IB are the major rivers flowing through this District. Covering a geographical area of 9712 SQ. KMs., Sundargarh District is the second largest District of the state, accounting for 6.23 percent of its total area. Out of this total area, forests cover 4232.57 SQ. KMs., this being the second largest in the state, accounting for 8.53 percent of the state total.

Sundargarh District has 3 sub divisions, 18 Tehsils, 17 Blocks and 279 Gram Panchayats and 1779 no. of villages (includes 8 Census Towns and 9 out growths) and 04 Urban Local Bodies. Topographically, this district is located between latitude 21 degree 36' N to 22 degree 32' N and longitude 83 degree 32' E to 85 degree 22' E. The population of this District is 20,93,437, which is fifth most populous District of the state, out of which the rural population is 13,55,340 and urban population is 7,38,097 and **the TRIBAL population of the district is 10,62,349, which is more than 50% of the total population.** The literacy rate of the district is 73.34%.

**The tribals all over the state/country particularly in the area of Sundargarh are known for their performing arts in the form of indigenous tribal songs, music and rhythmic dance. Music and dance forms an integral part of their life and living. The dances and songs of tribals as well as the music they play with their traditional musical instruments are so vibrant and rhythmic that many foreign visitors evince interest to visit tribal pockets only to catch a glimpse of such music and dance. But with changing times, the melodious song, music and dance forms of tribal are in the process of dying out.**

**The tribal people have extra ordinary sports talents, whose reflections are found in their culture and lifestyle also. Many players from Odisha, especially from Sundargarh district like Jerina Tirkey, Dipika Toppo, Asha Kerketta and Anita Kerketta are among several emerging girls from the tribals of Sundargarh district in hockey, who share a dream – they all want to play hockey professionally and represent India internationally just like Dilip Tirkey, Lazarus Barla, Subhadra Pradhan, Jyoti Sunita Kullu and Binita Toppo as done in the past. Padmashree Dr. Dilip Tirkey also captained the Indian Hockey Team. After all, both girls and boys at village level in Sundargarh district are making India proud. Accordingly, if they will be provided with proper shoes & shocks, dresses and other accessories, then their performance will definitely get a boost.**

**Similarly, so many players both girls and boys from the villages are rising under football game also. It is the time to improve their talents by participating in different tournaments at block, district and National level. Accordingly, if they will be provided with shoes & shocks, jersey and other accessories relating to football game, their performance will definitely improve.**

The climate of this District is characterized by extremely hot summers and cool winters. Climate is hot & moist sub humid. Normal rainfall of the District is approximately 1230 mm, but there is a deviation in receipt of rainfall pattern which is influencing crop production.

Sundargarh is recognized as an industrial district in the map of Odisha. Steel Plant, Coal Mines, Power Plants, Fertilizer Plant, Cement factory, Ferro Vanadium Plant, Machine building factory, Glass and china clay factory and Spinning mills are some of the major industries of this District. Sundargarh occupies a prominent position in the mineral map of Odisha and is rich in iron ore, limestone, manganese, dolomite, and fire clay. Major industries are the Odisha Cements Ltd, Hart Fertilizers Ltd, and Odisha Industries Ltd. The industrial town of Rourkela in this District has the first government sector plant built with foreign collaboration and was the first in India to use LD oxygen technology.

The sports materials as per list at Annexure-I should be of good quality. Priority will be given to the bidders considering the quality of materials and price quoted thereof. Approximately 50 sets of sports materials for hockey and 50 sets of sports materials for football will be required to be supplied to the tribal youth clubs. The requirement may exceed or decrease depending on the actual requirement and orders will be placed accordingly from time to time during the period of Annual Rate Contract. **The bidders are required to quote their rate item-wise/unit-wise in the enclosed prescribed Format of Financial Bid for hockey at Annexure-II/9 and for football at Annexure-II/10.**

#### **Manufacturer/Supplier/Proprietor:**

1. A person, group, or company that owns or runs a manufacturing plant.
2. A person, group, or company that manufactures/ Authorized Supplier.

1. **Eligibility Criteria:**
  - 1.1 All manufacturers/ Suppliers/ Proprietors dealing with supply of musical instruments and costumes for tribal.
  - 1.2 Preference shall be given to the manufactures/ Suppliers/ Proprietors of Sundargarh district.
  - 1.3 The Supplier should have valid Income Tax( PAN)/Sales Tax Registration Certificate.
  - 1.4 The Financial Bid (Annexure-II) should also be accompanied with the tender document.
  - 1.5 All the terms & conditions of DTCN must be fulfilled by the bidders and the required amount towards Cost of Tender Paper & EMD must be submitted in shape of Demand Draft alongwith tender documents.
  
2. **Scope of work:**
  - 2.1 The broad scope of the work would be design, supply and transportation of musical instruments and costumes for tribal to blocks/ Registered Club/ Community Centre point by whom Supply Order are to be placed.
  - 2.2 The block-wise requirement of the musical instruments and costumes of tribal and sports materials both under hockey and football will be provided along with the supply order. The supply order will be given by the concerned blocks/ Groups/ Clubs and the payment will also be released to the concerned suppliers by the BDO/Concerned Registered Club/ Community Centre.
  - 2.3 A clear understanding on the supply to the assigned Registered Club/ Community Centre/ Groups under 03 ITDAs of Sundargarh district is available with the District Cultural Officer, Sundargarh and District Sports Officer, which can be enquired through their contact numbers mentioned in the FACT Sheet, which requires a prior discussion.
  - 2.4 Storage facility of the items to be supplied should be provided by the Supplier for inspection at intermediate points for facilitating the process.
  - 2.5 The Agencies shall have to supply the items to the Registered Club/ Community Centre/ Groups as per the work order. Intended Suppliers are advised to collect all necessary information before hand about approach road to the village, distance and mode of transportation etc, before submitting the Annual Rate Contract.
  - 2.6 Proper storage of musical instruments and costumes and spots materials shall be the responsibility of the Suppliers. The name of Registered Club/ Community Centre/ Groups will be provided with the work order. In some cases, actual number of items to be supplied may vary to some extent, hence suppliers are required to seek confirmation in this regard from District Culture Officer, Sundargarh and District Sports Officer, Sundargarh, as the case may be, prior to dispatch of musical instruments and costumes and sports materials respectively.
  - 2.7 After supply of the musical instruments/ costumes and sports materials to the Registered Club/ Community Centre/ Groups in the specific locations as per instruction of the District Cultural Officer/ District Sports Officer/ Concerned PA, ITDAs/Authorized Officer, the Suppliers shall obtain acknowledgement from the concerned Registered Club/ Community Centre/ Group about receiving the musical instrument/ costumes/ sports materials in good condition.
  - 2.8 The date of commencement of supply shall be reckoned as the date of issue of Supply Order.
  - 2.9 All necessary conditions as further outlined in the subsequent sections of this document are to be followed.

### 3. **Instructions to Bidders:**

- 3.1 Bidders must submit their bid through proper means.
- 3.2 Bid must be submitted in English language only.
- 3.3 Incomplete, telegraphic or conditional bids shall not be accepted.
- 3.4 Prices quoted must be firm and fixed. No price variation / escalation shall be allowed.
- 3.5 The bidders/ authorized Agent must sign at the bottom of each page of the bid documents at the time of submission in token of unconditional acceptance of the departmental terms and conditions, technical specifications etc.
- 3.6 Copy of IT returns Statement / Valid GSTN/Copy of PAN card etc. duly attested must be submitted along with the bid.
- 3.7 Deviations in terms and conditions, Inspection clause etc. would not be accepted under normal conditions. However, under exceptional situation the same may be considered at the discretion of authority.
- 3.8 The quantity of materials to be purchased are subject to alteration without any notice.
- 3.9 Since timely supply of materials are of paramount importance, requests for extension of time shall not be entertained.
- 3.10 Canvassing in any manner shall not be entertained and will be viewed seriously leading to rejection of the bid.
- 3.11 All essential supplementing documents should be signed in case of need for verification, originals should be produced.
- 3.12 Earnest money/ Tender Paper Cost must be deposited in shape of Demand Draft to be drawn in favour of the **Project Administrator, ITDA, Sundargarh** payable at **Sundargarh** from any Scheduled Bank. **Bids without E.M.D and Bid Cost will be rejected.**
- 3.13 **The last date of receipt of the bid through OFF-LINE mode i.e. by Registered Post/ Speed Post (Post Office only) is up to 5.00 P.M. of 16.07.2018, after which the tender documents if any to be received by the office will be rejected.**
- 3.14 **The bid documents received in OFF-LINE mode through Registered Post/ Speed Posts by the date line shall be opened on 17.07.2018 at 03.00 PM** in the office chamber of the Collector, Sundargarh in presence of the bidders or their authorized representatives, who may like to be present at the time of opening.
- 3.15 The bidders during supply of the materials are required to fix with **logo of Special Development Council to be supplied by ITDA, Sundargarh** to the selected suppliers, after the tender is finalized.
- 3.16 Power of attorney to sign the agreement on behalf of bidders & partnership deed articles, if any, should be enclosed along with original bid documents.
- 3.17 Notice inviting tender, bid documents, prescribed price bid, terms & conditions will form the part of the tender.
- 3.18 In case of supply of any defective material or substandard material, the materials will be rejected & it will be the responsibility of the supplier for taking back & replacing the rejected materials at their own cost. In case of non-lifting of such rejected materials within a reasonable time offered by the office, it will have the right to suitably dispose of the same and forfeit the amount.
- 3.19 The supplied materials should be strictly complied with the specifications as mentioned in the bid; otherwise the material would be liable for rejection.

- 3.20 Bidders may in their own interest visit the sites or undertake field enquiry of the proposed places before submitting bids. SDC, Sundargarh will not be responsible for any incidental or consequential losses of the firms during supply of materials.
- 3.21 All bids received will remain valid for a period (90 days) as specified in the Contract Data after the deadline date for submission of bids and validity of bids can also be extended if agreed to by the bidder and the Department.

(4) **Procedure for opening of Tender:**

6. **Earnest Money Deposit:**

6.1 The earnest money deposited (EMD) is to be paid through Demand Draft issued from any Scheduled Bank in favour of the Project Administrator, Sundargarh and should be enclosed with the bid documents..

6.2 Unsuccessful Bidder's EMD will be discharged/ returned as promptly as possible within thirty (30) days after the issuance of work order to successful bidder.

**The bid security may be forfeited:**

- a) if a Bidder :
  - (i) Withdraws its bid during the period of bid validity specified by the Bidder on the Bid Form.
  - (ii) in case a successful Bidder fails to sign the Contract within the specified period.

7. **Payment Terms:**

Payment under normal circumstances will be done as detailed below;

- i) The Payment will be released by the BDO concerned/ Registered Club/ Community Centre only after supply of the intended materials in good condition, on production of necessary bills/ vouchers in this regard by the Supplier. The Suppliers are also required to furnish a certificate to that effect regarding handing over of the materials.

8. **TERMS & CONDITIONS:**

- (a) The Bid documents shall be submitted by Registered Post/ Speed post only in the address of Project Administrator, Sundargarh, At/Po-Sundargarh, District- Sundargarh, PIN-770001, Odisha. Conditional tenders and tenders without EMD shall be rejected.
  - (b) The Rates quoted should be on the basis of FoR destinations anywhere in Sundargarh district. Prices to be quoted in Financial Bid will be with all applicable taxes. to Quoted rates shall be valid for one year from the date of opening of tender as this is Annual Rate Contract.
9. The bidders from Sundargarh district should be given priority during finalization of tender.
  10. ITDA, Sundargarh/ Special Development Council, Sundargarh reserves the right to split the work order on the lowest quoted rates to one or more than one qualified bidders other than Lowest-1 for early supply of materials or any other reasons, if requires. The decision of SDC, Sundargarh regarding quantity will be final and binding on selected bidders in this case.
  11. The material shall be supplied at the specified site after confirming from the District Culture Officer/ Concerned PA, ITDAs.
  12. The work order(s) shall be placed depending upon the requirement of the agency from time to time within the validity period of tender.
  13. All disputes relating to this work shall be subject to the jurisdiction of Sundargarh district headquarters and Collector, Sundargarh shall be the sole arbitrator.
  14. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason in the interest of the SDC, Sundargarh.
  15. Transit Insurance if any to be required will be taken by the Supplier at his own cost
  16. Conditional offers with addition/ omission to original DTCN are liable to be rejected.
