

The EMD is to be deposited **in shape of NSC/Postal Term Deposit / F.D.R or T.D.R in Bank/Bank draft** of any nationalised bank along with tender documents duly pledged in favour of **ZSS, NRHM, Additionality Sundargarh.** Transfer or adjustment of EMD will not be entertained. Further, conditional tenders are not acceptable.
