AUCTION SALE NOTICE



Sealed Tenders are invited for auction sale of one Mobile Van - Model No. Tata 609 (Diesel) bearing No. OR 02D-5908 of Odisha State Civil Supplies Corporation Ltd., Sundargarh, on "as is and where is basis, including the present status of vehicle documents". The intending tenderers are requested to submit their tenders in plane paper offering their bids duly sealed along with one Bank Draft, worth Rs. 1000.00 (Rupees One thousand) only drawn in any Nationalized Bank as E.M.D. in favour of District Manager, OSCSC Ltd., Sundargarh. The tenderers are required to send the tender papers strictly through Registered post/ Speed Post/ Courier Services. The last date of receipt of tender is dt. 04.09.2018 at 03:30 P.M. The tender papers received after the specified date and time as mentioned above, shall not be entertained and the same shall be out rightly rejected. The sealed tenders shall be opened on dt. 05.09.2018 at 11:00 A.M., in the office chamber of CSO-cum-District Manager, OSCSC Ltd., Sundargarh in presence of the tenderers or their authorized representatives. The tenderers may inspect the vehicle kept in the premises of Asst. Civil Supplies Office, Udit Nagar, Rourkela during any working day from 10:30 AM to 05:00 PM.


The up-set price of vehicle No. OR 02D-5908 - Rs. 55,000.00

Terms and conditions:


1. Quotation should be sent by mentioning "Auction sale of the vehicle No. OR 02D-5908" on the top of the closed envelope containing the E.M.D.
2. The tenderer with highest bidding be selected by the competent authority. He shall deposit 25% of the bid amount immediately on the spot and rest amount shall be deposited within seven days or at the time of taking delivery of the vehicle, whichever is earlier.
3. The E.M.D. of all unsuccessful tenderers will be refunded to them on the same day.
4. If the price offered by sealed tenders are found less than the upset price, then competent authority may go for fresh auction sale or negotiation may be made with all the present tenderers to fetch the minimum up-set price as desired by the authority.
5. In case the successful tenders fails to deposit 75% of balance auction price at the time of taking delivery of vehicle within 7 days, his tender paper will be cancelled and the E.M.D. along with 25% deposit will be forfeited.
6. The highest bidder will remove the vehicle within 15 days of deposit of the total amount, failing which ground rent of Rs. 100/- per day will be charged till final removal of vehicle.
7. After change of ownership in favour of highest bidder or cancellation of registration of the vehicle at RTO, BBSR/Sundargarh the vehicle will be handed over to the highest bidder subject to production of documents in this respect.
8. Where the ground rent so charged exceed the price deposited by the tenderer, shall ceased to have any right on the vehicle and amount so deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will be disposed of by fresh auction/ tender as the case may be.
9. The successful tenderer/ party shall have to deposit the cost along with statutory dues like sale tax/GST etc. as admissible under Rules.
10. All other terms & condition as applicable for auction sale of Govt. vehicle are remain unchanged.
11. The District Manager reserves the right to accept or reject any or all the tender papers without assigning any reasons thereof.




