5) **Earnest money deposit** :- The E.M.D. is to be deposit in shape of post office short term deposit/term/ deposit/N.S.C./KVP/Deposit receipt of any nationalized bank duly pledged in favor of Block Development officer,Hemgir. The Tender papers without required amount of E.M.D. will not be considered and transfer or adjustment of E.M.D is also inadmissible.

6) **Documents to be attached** :- The following document should be furnished with the tender papers failing which the tender will be liable to rejection.(a)Tender paper cost in shape of DD infavor of the Block Development Officer,Hemgir,(b) E.M.D pledged in favor of the Block Development Officer,Sundargarh,(c) Attested copy of contractor Registration Certificate,(d)Attested copy of PAN Card,GST Registration certificate (e) Affidavit as regards the fact of availing award of work (F) Sechedule-F (G)Attested copy of labour lince or Undertaking (H) Attested copy of Caste Certificate issued by competent authorities in case of S.C/ S.T. contractors desirous of availing preference,(H) Schedule -a (Certificate of No Relationship), (I) Schedule- E(Information regarding current Litigation,Debarring Expelling of Tendered or Abandonment of Work by the tenderer).

7) if any of the bidder quotes less than 15% of the Tendered amount .Then such a bid shall be rejected and the Tender shall be Finalised basing on marit of the rest bids and the Odisha will be followed. laid down in clause no 36 of memorandum no 12366, dated 08.11.2013 of works Departmenty.Govt. of

8) **Additional performance Security Deposit** :- Additional performance Security shall be deposited by the bidder,where the bid amount is less than the estimated cost put to tender.In such an event,only the sucessful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish thct amount of different cost i.e estimated cost put to tender minus the quoted amount as Additional performance Security (APS) in shape of Demand Draft/Term Deposit Receipt in favour of the Block Development Officer,Hemgir within seven days,otherwise the bid shall be cancelled and the security deposit shall be forfeited.further proceeding for blacklisting shall be intiated against bidder.

9) The E.M.D. amount will be forfeited,if the tenderer backs out form the officer acceptance off tender,by the competent authority.

10) Submission of more than one tender paper by a bidder for single work will be liable for rejection of all such tender paper.

11) On review of the last performance of the work executed through B.D.O., Hemgir ,the lowest -1 tender may/may not considered for the works through he/she becomes lowest-1 tender.

12) The contractors who have failed to execute projects of this agency /backed out from execution process/abandoned the project work midway/those who have been declared by this agency to be defaulters otherwise will not be allowed to participate in the present tender process. If any such contractor participates than his /her papers will not be considered at all .

13) **G.S.T. shall be paid extra as applicable .**

14) The undersigned seserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.
