- B) Each bidder shall submit self copies of Pan Certificate, GSTIN Certificate, Service Tax registration & Provident fund registration, Authorized agency certificate and contractor registration certificate not less than "C" class for equivalent work limit for other state.
- C) Bidder shall submit Chartered Accountant attested turnover Certificate for last three years for average turnover not less than 50% of estimated cost.
- D) Bidder shall submit certificate of similar work done satisfactorily, issued by the officer not less than rank of the Executive Engineer on Contactor's name for at least two projects strictly as per approved specifications for all items mentioned in bid in any of the last 5 (Five) years .
- E) If bidder is contractor, manufacturer ,upon awarded the job than bidder shall submit one year & six months warranty, assurance letter against any manufacturing defect strictly on manufacturer letter head or manufacture's name for validation and IS/ISO valid registration certificate for all items mentioned in the bids.
