1. Bid document consisting of plans, specifications, the schedule of quantities and the set of terms & Conditions of contract and other necessary Documents can be seen in the website www.tendersodisha.gov.in.

2. The tender must be accompanied with EMD of the amount as in col.4 (1% of the estimated cost) to be deposited online through a process as mentioned in the Bid Documents. Engineering (Degree/Diploma/Graduate Architecture) contractors desirous of exemption of EMD should furnish affidavit in this regard that they have not availed exemption for more than the prescribed limit along with the tenders as well as to submit original license at the time of opening of the Tender. Adjustment of EMD, deposited for other works in this Division will not be entertained for the above work. All other terms and conditions can be had from the office of the undersigned during office hours. Bidders desirous to hire machineries of equipment from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.

1. **Engineer contractors who want to avail EMD exemption** have to **submit one affidavit** with tender declaring therein to the effect that they have not yet availed **3** (three) nos of EMD exemption during the financial year **2018- 2019** and to show the original Registration Certificate to the tender opening authority for confirmation at the time of opening.
2. The Bid documents should be up-loaded by the Bidders on-line in www.tendersorissa.gov.in accompanying the scanned copies of valid Registration certificate, GST registration certificate, PAN card, cost of tender paper, performance record in proper format as per Annexure-A attached in the DTCN. No relation certificate & affidavit about the authenticity of the tender documents. clear scanned copy of original valid license, affidavit regarding authenticity of document and affidavit to avail price preference in case of SC/ST contractors, should be uploaded **for each work separately** along with the bid document failing which the tender will be treated as non responsive. Non-submission of Bid security and cost of tender papers within the designated period shall debar the bidder from participating in the online bidding system and also his portal registration shall be blocked. His name shall be reported to the registration authority for cancellation of his / her registration as contractor as per Works Deptt. No. F.A.R- 3/08-1027/W dt. 24.01.2009.

 The Bid documents will be available in the website www.tendersodisha.gov.in from **10.00 AM of 05.02.2019 to 5.00 PM of 14.02.2019**

4. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
5. Bids shall be received only “**On-line**” on or before **5.00 PM of 14.02.2019**
6. Bids received “on-line” shall be **opened at 11.00 AM . on 15.02.2019** in the office of the **Executive Engineer , Minor Irrigation Division, Sundargarh** in the presence of bidders who wish to attend. Bidder who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The cost of bid document for each work has to be transferred online through a process as mentioned in the Bid Documents. **Bidder who have participated in online tender must have to deposit the bid cost. Non-submission of bid cost shall debar the bidder from participating in the on-line bidding system and informed to the authorities for cancellation of his contractor registration and also portal registration .**
8. **The bidder shall have to transfer the ‘bid security’ online through a process as mentioned in the Bid Documents, failing which the bid will be rejected.**
9. The authority will not be held responsible for any technical snag or network failure during on-line bidding.
10. The bidder must go through the Bid Documents meticulously before up-loading the tender to the web-site.
11. Any corrigendum / Addendum will be displayed in the website www.tendersodisha.gov.in
12. Other details can be seen in the bid documents.
13. The authority reserves right to cancel any or all bids.
14. Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Term Deposit receipt pledged in favour of the Divisional Officer/Bank Guarantee in favour of the Divisional Officer from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to successful bidder otherwise the bid of successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder in pursuance to Works Department Office Memorandum No 14459/W dated 20.09.2018 as sub Rule ‘g’ under Rule A of Appendix-XXXIV of OPWD Code Vol-II. (OM No 14402 dated 6.10.2017 of Works Department). **Non furnishing of APS within stipulated period is a ground for blacklisting of contractor.**

15. The bid must be accompanied by the scan copy of the PAN card and other documents as required in the DTCN and also submit an affidavit regarding the authenticity of the documents.

16. THE AGENCY HAS TO BEAR THE COST OF ALL QUALITY CONTROL & MIX DESIGN TEST AS REQUIRED FROM TIME TO TIME.

17. A General guideline on Extension of time has been issued vide Ir no 20415 dated 14.09.2015 of the FA-cum-Joint Secretary to Govt. DOWR, Govt. of Odisha for information of Contractors for preparing the work programme, planning and schedule.

18. GST will be deducted from each RA bill of the contractor as per the prevailing rate. In case any amendment to the existing provisions is made by the Government during the tenure of the contracts, the same will be applicable to this contract.

19. Electronic receipt of cost of tender paper has been successfully tested through SBI payment gateway. Now it has been decided to introduce electronic receipt of **Cost of Tender Paper and Earnest Money Deposit on submission of bids** through payment gateway of designated banks such as SBI/ICICI Bank/HDFC Bank for all Government Departments, State PSUs, Statutory Corporations, Autonomous Bodies and Local Bodies etc. in phases (ANNEXURE-I). The process outline as well as accounting and reporting structure are indicated below :

a) It will be carried out through a single banking transaction by the bidder for multiple payments like **Cost of Tender Paper and Earnest Money Deposit on submission of bids.**

b) Various payment modes like Internet banking/ NEFT/RTGS of Designated Banks and their Aggregator Banks as well can be accessed by the intending bidders.

c) Reporting and accounting of the e-receipts will be made from a single source.

20. Penalty will be imposed as per agreement condition if the work is not completed within the stipulated period or the progress of work is not as per the work programme.

21. Amendment to Para 3, 5 & 18 rule 29 of Appendix-IX of OPWD code Vol.-I **“The Single tender received in the 1st call shall be cancelled without opening of the bid & fresh tender will be invited”** as per Office memorandum no 16 dated 01.01.2015 of Works Department Govt. of Odisha

22. Agreement will be drawn/works will be taken up as per the availability of funds.

23. If the office happens to be closed on the last date of closing or opening of the bids as specified, holidays in Government local authority the tenders will be closed or opened on the immediate next working day at same time and venue respectively, as the case may be.

24. No Extension of time beyond Agreement period will be allowed in this projects.

25. For delay in completion of the project, penalty will be decided by the Chairman and Chief Executive Officer of the executive committee of District Mineral Foundation.

26. If any Contractor/ Agency / Vendor/ Supplier will fail to execute to or more nos. of works under DMF with in the stipulated time period as per agreement, they will be restricted and black listed from execution of any work under DMF in Sundargarh District
