



02. The bidders must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
03. The Authority will not be held responsible for any technical snag or network failure during online bidding.
04. Authority reserves the right to reject any or all the tenders without assigning any reason thereof.
05. The Bidder may ask questions for clarification in the e-procurement portal using his/her DSC from **Date 06.02.2019 to Date 16.02.2019 DURING THE OFFICE HOURS i.e. from 10.00 A.M. to 5.00 P.M.**
06. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender (Col-3) as Bid Security.
07. Subsequent corrigendum/addendum if required shall only be available in web site indicated above.
08. Scanned clear copies should be uploaded. **Non-visible copies of Documents may be liable for rejection.**

10. **The Original affidavit regarding correctness of all documents for each work separately should be made and scan copy of such affidavit is to be uploaded online failing which his tender will not be considered and rejected during opening of tender.**
11. Bidders are to fill up the personnel details in the data sheet available with the uploaded documents.
12. As per the circular No.13286 dated. 07.09.2017 of Govt. of Odisha, Amendment to Para 3.5.5(V) of Note-II of OPWD Code Vol-I by modification vide Office memorandum No. 5288 dated. 04.05.2016 of Govt. of Odisha Works Department being quashed, the **successful bidders**, (who have quoted less bid price / rates than the estimated cost put to tender) are required to deposit the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of NSC/POTD/Term Deposit Receipt pledged in favour of the Executive Engineer Minor Irrigation Division, Sundargarh within 7 (Seven) days from the date of declaration as successful bidder for final consideration of their tenders, otherwise action will be taken as per the memorandum No. 12366, dated. 08.11.2013 of Works Department, Odisha, Bhubaneswar.
13. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on the merits of the rest of bids. But if more than one bid is quoted at 14.99% (decimals up to two numbers will be taken for all practical purposes) less than the tender amount, the tender will be finalized through a transparent lottery system in the presence of all bidders/their authorized representatives, the Executive Engineer and Divisional Accounts Officer.
14. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or administrative Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without Government permission.
15. Tender paper cost, EMD, PAN, GSTIN Registration certificate, No relation certificate in shape of affidavit, clear scanned copy of Certificate of SSI units( MSEs), affidavit regarding authenticity of document, should be uploaded **for each work separately** along with the bid document. As per Clarification of DOWR, Govt of Odisha vide letter No. 14318 dated 24.05.2018 since the SSI Units have participated in tender for execution of works contract, **they not entitled for exemption from payment of EMD/Security Deposits/Tender Paper Cost as per the provision exist in OPWD code.**

16. The successful bidder shall have to produce original Certificate of SSI units( MSEs), GSTIN PAN for verification before drawl of agreement and furnish the attested Xerox copies of such documents at that time.

17. Penalty will be imposed as per agreement condition if the work is not completed within the stipulated period or the progress of work is not as per the work programme.

18. Amendment to Para 3, 5 & 18 rule 29 of Appendix-IX of OPWD code Vol.-I "**The Single tender received in the 1<sup>st</sup> call shall be cancelled without opening of the bid & fresh tender will be invited**" as per Office memorandum no 16 dated 01.01.2015 of Works Department Govt. of Odisha

19. Agreement will be drawn/works will be taken up as per the availability of funds.

20. The successful bidder will procure the bought out items from reputed manufacturers with relevant test certificates & warranty certificates, which may be submitted to Executive Engineer, M.I. division, Sundargarh before assembly / erection inside fabrication shop/ at site for inspection.

21. The successful bidder shall have to execute the work as per scope of work, relevant drawings, technical specifications, terms and conditions of agreement.

22. Any dispute arising out of this tender or order thereof is to be settled in proper court under the jurisdiction of Odisha High Court at Cuttack or courts under the jurisdiction of Odisha High Court at Bhubaneswar only.

23. Successful tenderer will be intimated for drawl of agreement.

24. The tender will be processed / considered as per office memorandum issued by the Works Department Government of Odisha vide No. 12366 dated. 08.11.2013.

25. If the office happens to be closed on the last date of closing or opening of the bids as specified, holidays in Government local authority the tenders will be closed or opened on the immediate next working day at same time and venue respectively, as the case may be.

26. Prevailing rate of G.S.T. on the gross amount of bill will be deducted from contractor's bill as applicable on the date of payment.


27. No Extension of time beyond Agreement period will be allowed in this projects.


