The intending tenderers may inspect the vehicles at the Office premises on any working day during office hours within **15** days from the date of publication of the tender notice.


All the tenders received will be opened in presence of the tenderers or their authorized agents if present at 11 AM . on 11.03.2019 .If the said date declared as Govt. Holyday the tenders will be opened on the next working day as per the scheduled time. Delay in postal delivery shall not be taken into consideration. The tender cover should be subscribed as "TENDER FOR VEHICLE".

The tender must accompany with the amount of earnest money (EMD) as mentioned against the vehicle in shape of Account Payee Bank Draft drawn in favour of the C.D.V.O., Sundargarh . and payable at S.B.I. Sundargarh. No tender will be considered valid without payment of the earnest money. The earnest money deposited in shape of Bank drafts will be returned to the unsuccessful tenders only after finalization of the tenders.

Tender with highest offer of sale price shall be accepted and such tenderer shall have to deposit 25% of the offered amount of the vehicle on the day of acceptance and balance 75% within seven days of issue of the intimation letter. On failure to make payment the aforesaid deposit including Earnest Money shall be forfeited.

The vehicle should be removed from the site within seven days from the date of depositing the full amount of tendered/negotiated money. Tools, instruments and spare parts shall not be delivered with the vehicle. In case the vehicle is not removed, the custody and safety of the vehicles shall be the responsibility of the tenderer and no claim or complain on that account shall be entertained and ground rent at the rate of 1% of tendered/negotiated money will be charged for each day or part of the day till the removal of vehicle from the site.

Any litigation on this sale shall be subject to the jurisdiction of Sundargarh, Town only. The Chief District Veterinary Officer, Sundargarh reserves the right to accept or reject any or all tenders without assigning any reason thereof.
