
TERMS & CONDITIONS

2. Rate should be quoted clearly in both figure & words with correction duly attested by the quotationer inclusive of all taxes.
3. Intending quotationer should possess prior experience in execution of similar nature of work in govt. organizations / ULBs / PSUs etc.
4. The quotationer should submit detailed & satisfactory establishment information capable for preparation & supervision of such project.
