Advertisement was made vide this office letter No.2504/DRDA-RH dt.9.10.2019 inviting applications to fill up 53 nos. of posts of Gram Rozgar Sevaks (GRS) (U/R-27 nos. out of which Male 18 and Female-09, SEBC-5 nos. out of which Male 03 and Female 02, SC 09 nos. out of which Male 06 and Female 03, ST 12 nos. out of which Male 08 and Female 04) in different vacant GPs of Sundargarh district. Subsequently, the Government in PR & DW Deptt. vide their letter No.19697/PR & DW dt.1.11.2019 issued clarification regarding Post Based Reservation Policy to be followed while filling up the posts of GRS. Hence, further clarification was invited from the Government in PR & DW Deptt. vide this office letter No.47/DRDA dt.4.1.2020 since this district had already made advertisement basing on the vacancy based reservation. Accordingly, the Government in PR & DW Deptt. issued clarification vide letter No.2198 dt.28.01.2020 to fill up all the 53 nos. of vacant post of GRS in the following manner;

1. The candidates belonging to ST category may be allowed to participate in the recruitment process as Un-Reserved (U/R) candidates without claiming for reservation. If selected, they will be treated as U/R candidates.
2. The reservation in respect of the special categories like Sports Person (1% of the vacancies, Ex-Servicemen (3% of the vacancies), and Persons with Disabilities (PwD) (4% of the vacancies) etc. shall be adjusted against the categories to which they belong against the vacancy now to be filled up.
