Sealed Quotations/Tenders are invited from the interested reputed Travels Agencies/Tour Operators or Private Individuals for providing **2 (TWO) no. of BS-IV compliant Petrol (or Diesel) driven Vehicle** preferably **TUV300/Bolero/Sumo Gold/Ertiga** with Minimum Average Mileage of **10 (Ten) Kilometers per Litre** for official use in the Office of the **Panchayat Samiti, Hemgiron** monthly rent basis as per the terms and conditions at **Annexure-I**.

- 1) The Vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date Tax payment etc. which are mandatory for playing of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of **Rs.5,000/- (Rupees Five Thousand) only** shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **Block Development Officer, Hemgir to be drawn at Hemgir** and submitted along with the tender as **Security Deposit**. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
- 6) The Vehicle must achieve a fuel efficiency of **10 Kms. Per litre**.
- 7) The details of the make and year of manufacture of the vehicle, Registration No., mileage (Kms. Covered per Litre) and name of the Driver with Driving License No. and period of validity should be specifically provide in the general bid information to be furnished with the Quotation/Tender (**Annexure-II**).
- 8) The Quotation completed in all respect should reach the undersigned on or before **30.03.2020 by 01.00 PM** and shall be opened **on the same day at 04.00 PM** in presence of the bidders or their authorized representatives.
