

**AUCTION SALE NOTICE**

Sealed Tenders are invited for sale of unserviceable/Condemned different types of articles Such as **Wooden Chair, Table, Bench, Almirah & Rack** as per the following terms & conditions.

1. The Intending persons can obtain list of condemned articles i.e. documents from the Office of the undersigned as well as inspect the sales articles during the Office hours from **10.07.2020 to 20.07.2020**.
2. The Intending persons should quote their Bids against each item individually to participate in the Tender.
3. Tenders are required to enclose the EMD in shape of Bank Draft from any nationalized Bank amounting to **Rs.5,000/- (Rupees five thousand)only** not in Account Payee in favour of Additional District Magistrate, Sundargarh along with the Tender, without which the tender is liable for rejection.
4. The Tender will be received up to **3 PM** on dated **21.07.2020** and will be opened in the Office of the undersigned on the **same date at 4 PM** in the presence of the Tenders or their authorized representative if any.
5. The Tenders Who's Tender will be accepted shall have to deposit 25% of the offered amount immediately on the spot and balance of the offered amount will be deposited within 7 days from the date of intimation regarding acceptance of Tender. GST as applicable by the Govt. of India will be paid extra on the bidding amount by the Bidder at the time of disposal of condemned items, failing which the deposited amount including the earnest money will be forfeited and deposited in Govt. account and the articles will be put for fresh Tender.
6. The successful Tenders shall have to remove the condemned store articles at his own cost soon after deposit of full offered amount, if Tenderer fails to remove the auctioned store articles within the time limit, then the ground rent @ 1% of bidding amount will be charged for each day till removal of the articles.
7. The undersigned reserves the right to accept or reject any or all of the Tender without assigning any reason thereof.


