- 1) Cost of Tender Paper:** - The tender specifications can be obtained from the Office of the Block Development Officer, Hemgir on payment towards the cost of tender papers as mentioned above (Non refundable) in shape of Bank Draft drawn in favour of Block Development Officer, Hemgir, Sundargarh in any Nationalized Bank having its branch at Sundargarh on any working day from **10/08/2020 to 20/08/2020** for the above work.
- 2) Sale of Tender Papers:** - The tender documents will be sold from **10/08/2020 to 20/08/2020** at Panchayat Samiti Office, Hemgir between 11.00 A.M. to 5.00 P.M. on working days only.
- 3) Date of receipt and mode of submission of tender papers:** - The tenderers have to submit the sealed tender papers in complete shape through **Registered Post/Speed Post only** to the B.D.O., Hemgir, dist- Sundargarh.
- 4) The last date of receipt of tender papers are 21.08.2020 (5.00 P.M.).** The undersigned will not be responsible for postal delay if any or non-receipt of the papers in time. The tenderers must super scribe the name of the work project on the sealed envelopes.

- 5) **Date of opening of Tender Paper:** - The tender papers will be opened on **24.08.2020** at **11.00 A.M.** in the presence of the tenderers or their authorized representatives in the office of the undersigned.
- 6) **Earnest money deposit:** - The E.M.D. is to be deposited in shape of Post Office short term deposit/ term deposit/ N.S.C./ KVP/ Deposit receipt of any nationalized bank duly pledged in favour of Block Development Officer, Hemgir. The Tender Papers without required amount of E.M.D. will not be considered and transfer or adjustment of E.M.D. is also inadmissible.
- 7) **Documents to be attached:** - The following document should be furnished with the tender papers failing which the tender will be liable to rejection. (a) **Tender paper cost in shape of DD in favor of the Block Development Officer, Hemgir,** (b) **E.M.D. pledged in favour of the Block Development Officer, Hemgir,** (c) **Attested copy of Contractor Registration Certificate,** (d) **Attested copy of PAN Card, GST Registration certificate,** (e) **Affidavit as regards the facts of availing award of work,** (F) **Schedule-F** (G) **Attested copy of labour license or Undertaking** (H) **Attested copy of Caste Certificate issued by competent authorities in case of S.C./S.T. contactors desirous of availing preference,** (H) **Schedule-A (Certificate of No Relationship),** (I) **Schedule-E (Information regarding current litigation, Debarring expelling of Tendered or Abandonment of work by the tenderer).**
- 8) If any of the bidder quotes less than 15% of the tendered amount, than such a bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and the provision laid down in clause No.36 of Memorandum No.12366, dated 08.11.2013 of Works Department. Govt. of Odisha will be followed.
- 9) **Additional Performance Security Deposit:** - Additional Performance Security shall be deposited by the bidder, where the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder, where the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of different cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft/Term Deposit Receipt in favour of the Block Development Officer, Hemgir within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further Proceeding for blacklisting shall be initiated against bidder.
- 10) The E.M.D. amount will be forfeited, if the tenderer breaks out from the offer acceptance off tender, by the competent authority.
- 11) Submission of more than one tender paper by a bidder for single work will be liable for rejection of all such tender papers.
- 12) On review of the last performance of the work executed through B.D.O. Hemgir, the lowest-1 tender may/may not be considered for the Works though he/she becomes lowest-1 tenderer.
- 13) The Contractors who have failed to execute projects of this agency/broke out from execution process/abandoned the project work midway/those who have been declared by this agency to be defaulters otherwise will not be allowed to participate in the present tender process. If any of such contractors participates then his/her papers will not be considered at all.
- 14) **G.S.T. shall be paid extra as applicable.**
- 15) The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.
