Sealed Tender/Quotations/Bid are invited for **empanelment** of Goods Transport Agency/ Operators or Private Individuals who have GSTIN registered for providing vehicle for transportation of Goods, having TATA ACE/Force/Mahindra Minidor, vehicle total **6 no. of vehicle (it may be increase/decrease)** which shall confirm to the terms and conditions (Annexure-I) for transportation of goods to different Sub centers level in entire Rourkela as per the requirement of the City Health society, City Programme Management Unit, NUHM, Rourkela on daily basis.

- 1) The Vehicle must be in Road Worthy Conditions and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Goods Transport permit, proof of up to date tax payment etc which are mandatory for playing of vehicle. The undersigned reserves the right to give preference to the new vehicle.
- 2) The driver of the vehicle must have a valid Driving License for driving goods transport vehicle and should be sufficiently experienced in driving transport of Goods carrying vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) The Daily hire charges quoted including GST & any other taxes as applicable (if any).
- 5) The vehicle must achieve a **fuel efficiency of 10 KMs** per litre and the driver is to maintain log book properly on daily basis.
- 6) The details of the make and year of manufacture of the Vehicle, registration no, mileage (KMs covered per litre) and name of the driver with driving license No & period of validity should be specifically provided in the general bid information to be furnished with the tenders (Annexure-2)
- 7) A sum of **Rs.10,000/-(Rupees Ten thousand)** only shall be deposited by the intending bidders in shape of Demand draft drawn in Favour of **"CITY HEALTH SOCIETY NUHM ROURKELA"** payable at Rourkela and submitting along with the tender as Security Deposit. Annexure-I

Terms & Conditions for hiring of Vehicle

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on monthly hired basis.

- The hired vehicles during period of contract, shall have all necessary valid MV documents such as, valid registration certificate, insurance certificate, fitness certificate, valid contract carriage permit, proof up to date tax payment etc and D.L. of the driver available all the times. The authority shall not be responsible for any damage/loss caused to hired vehicles or loss of life/Injury made to any person or damages to any property on account to use of hired vehicle any manner whatsoever. The hirer shall not be responsible for all such litigation.
- The per day hire charges (including hire charges and actual consumption of fuel) to be on daily basis in the mode of e-transfer/PFMS. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, tyres, tubes, battery etc will be borne by the bidder.
- It shall be the responsibility of the bidder to provide a good, well behaved driver and the salary of the driver shall be borne by the owner.
- In case of breakdown for reasons whatsoever the replacement of a vehicle or the same or better model shall be provided by the owner of the vehicle/bidder.
- In case of the vehicle do not report timely, the authority will be at liberty to reject the agreement and may disengage the vehicle.
- The vehicle shall report for duty with timeliness and need of the hour as per requirement of the undersigned.
- In case emergency, the driver will have to report for duty as per the requirement of hirer. No extra payments shall be demanded.
- Hire charges and reimbursements towards cost of diesel (as per actual) of selected bidder will be paid in, as soon as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
- If the services of the service provider are found to be un-satisfactory, the client shall be given one month notice for termination of agreement.
- In case the service provider intends to withdraw the services of his/her vehicle and terminate the agreement, the EMD will be forfeited.
- The contract period of the agreement will be of 12 months during initial period which may be extend up to next 12 months subject to satisfactory performance.
- Rates quoted against this tender enquiry shall remain valid up to 12 months after publication of approved rate. No request for increase in rates, if any, will be allowed or entertained during this period.
