Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.


(N.B:- EMD in shape of cash / pay orders or Bankers Cheques / Bank Draft is not acceptable.)

- 3 The bidders who have quoted less bid price/ rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as **Additional Performance Security** in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the **Block Development Officer, Kuarmunda** in the sealed envelope along with the price bid at the time of submission of bids. In case of the bidders quoting less bid price/rate than the estimated cost put to tender and have not furnished the exact amount of differential cost (i.e. estimated cost put to tender minus the quoted amount) as **Additional Performance Security** in shape of Demand Draft/ Term Deposit Receipt their price bid will not be taken in to consideration for evaluation even if they have qualified in the technical bid evaluation.
- 4 The sale of the Bid documents shall start from **dt.24.12.2020 at 3 PM and close on dt.08.01.2021 at 5 PM** during office hours in the office of the undersigned. Bids shall be received on or before **5.00 PM of 08.01.2021 through Regd. Post or Speed Post only**. The authority will not be held responsible for any postal delay in delivering of the bid documents or non-receipt of the same.

Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
