- 2) **Sale of Tender Papers** :- The Tender documents will be sold from **04.01.2021 to 18.01.2021** at Block Office, BONAIGARH between **10 A.M. to 5 P.M.** on working days only.
- 3) **Date of receipt and mode of submission of Tender Papers** :- The tenderers have to submit the sealed papers in complete shape through Registered Post/Speed Post only addressed to the Block Development Officer, BONAIGARH, Dist: Sundargarh, PIN: 770038 superscribing "**TENDER DOCUMENTS FOR _____ (mention the project name here)**" on the top of the sealed envelope. The last date of receipt of tender papers is **19.01.2021(5.00 P.M.)**. The undersigned will not be responsible for postal delay, if any or non-receipt of the papers in time.
- 4) **Date of Opening of Tender Paper** :- The tender papers shall be opened on **20.01.2021 at 11 A.M** in the presence of the renderers or their authorized representatives having written authorization for the purpose and tender committee.
- 5) **Earnest Money Deposit** :- The E.M.D is to be deposited in shape of Term Deposit/N.S.C/KVP in any post Office or Term Deposit in any Nationalized Bank duly pledged in favor of Block Development Officer, BONAIGARH. The Tender Papers without required amount of EMD will not be considered and transfer or adjustment of EMD is also not admissible.
- 6) **Document to be attached** :- The following documents should be furnished with the tender papers, failing which tender will be liable for rejection: a) E.M.D pledged in favour of the Block Development Officer, BONAIGARH, b) Attested copy of contractor Registration Certificate, c) Attested copy of PAN Card, valid GST Registration d) Attested copy of Caste Certificate issued by competent authorities in case of S.C/S.T contractors desirous of availing preference, e) Affidavit as regards the fact of availing award of work without submission of E.M.D during the current financial year in case of Engineer Contractors desirous of availing exemption of E.M.D.
- 7) If any of the bidder quotes less than 15% of the tendered amount, than such a bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and the provision laid down in clause No. 36 of Memorandum No. 12366 dated 08.11.2013 of Works Department, Govt. of Odisha will be followed.
- 8) **Additional Performance Security Deposit** :- The successful bidder those who have quoted less bid price/ rate than the estimated cost put to tender shall have to furnish exact amount of differential cost i.e; estimated cost put to tender minus quoted amount as Additional Performance Security in shape of term deposit/N.S.C/K.V.P/Deposit receipt of any Nationalized bank duly pledged in favour of the Block Development Officer, BONAIGARH within 7 days of issue of letter of acceptance (LoA) and before execution of agreement, failing which the bid of successful bidder(s) shall be cancelled and the E.M.D shall be forfeited followed with initiation of proceeding for black listing the bidder(s).
- 9) The E.M.D amount will be forfeited, if tenderer backs out from the offer of acceptance of tender by the competent authority.
- 10) Submission of more than one tender paper by a bidder for single work will be liable for rejection of all such tender papers.
- 11) On review of last performance of the work executed through Block Development Officer, BONAIGARH the lowest-I tender may or may not be considered for the works though he/she becomes lowest-I tenderer.
