Sealed Quotation/Tenders are invited from interested reputed Travel Agencies/Tour Operators or Private individuals for providing one no. of A.C. vehicle (TUV 300/Bolero/Sumo Gold/Ertiga) having sitting capacity not more than ten including driver, which shall conform to the terms and conditions (Annexure-II) for Official use in Office of the Tahasildar, Tangarpali District Sundargarh on monthly rent basis. The undersigned reserves right to change the date or cancel the entire tender process at any time without assigning any reason thereof.

1. The vehicle must be in Road Worthy condition, shall not be more than three years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc., which are mandatory for plying vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs. 5,000/- shall be deposited by the intending bidder in shape of Account payee Bank Draft in favour of the Tahasildar, Tangarpali and submit along with the tender as a security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidder.
5. The monthly rate of hire charges be quoted separately in the general bid information (excluding fuel and lubricants). The maximum hire charge per month approved by the Government is Rs. 31,000/- only.
6. The vehicle must achieve a fuel efficiency of 10 Kms. Per litre.
7. The details of make and year of manufacture of the vehicle, registration No. milage (Kms. Covered per litre) and name of the driver with driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/Tender (Annexure - III).
8. The quotation completed in all respect should be dropped in the sealed tender box kept in the Office Chamber of the undersigned on or before 25.02.2021 by 11.00 A.M. and shall be opened on the same day at 11.30 A.M. in presence of the bidder or their authorized representative in the Office Chamber of the Tahasildar, Tangarpali.
9. The application form of quotation/tender containing General bid information and terms and conditions for hiring of vehicle etc. will be available in the Office of the Tahasildar, Tangarpali on payment of Rs. 100/- (Rupees One hundred) only w.e.f. 05.02.2021 to 24.02.2021 during Office hour on working days only.
10. As per instruction given in Letter No. 30464 /F. dt. 06.09.2019 of Govt. of Odisha, Finance Department, priority will be given to **BS-IV compliant Petrol Vehicle**.
11. Payment of hire charges and cost of fuel will be made as per availability of funds in proper head.


