

- Bids must be accompanied by **Earnest Money deposit / Bid Security & APS** of the amount specified for the work in the table col.4 above in shape of N.S.C/POTD/Post Office Savings Pass Book/ Deposit receipt of any scheduled Bank(valid minimum one year from the date of receipt) pledged in favour of **Block Development Officer, Gurundia** and will have to be in any one of the forms as specified in the bidding documents. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.
(N.B:- EMD in shape of cash / pay orders or Bankers Cheques is not acceptable.)
- The bidders who have quoted less bid price/ rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as **Additional Performance Security** in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the **Block Development Officer, Gurundia** in the sealed envelope along with the price bid at the time of submission of bids. In case of the bidders quoting less bid price/rate than the estimated cost put to tender and have not furnished the exact amount of differential cost (i.e. estimated cost put to tender minus the quoted amount) as **Additional Performance Security** in shape of Demand Draft/ Term Deposit Receipt their price bid will not be taken in to consideration for evaluation even if they have qualified in the technical bid evaluation.
- The sale of the Bid documents shall start from dt.25.02.2021 at 5 PM and close on dt.16.03.2021 at 5 PM during office hours in the office of the undersigned. Bids shall be received on or before 5.00 PM of 18.03.2021 through Regd. **Post or Speed Post only**. The authority will not be held responsible for any postal delay in delivering of the bid documents or non-receipt of the same
- The original Bid security along with bid document shall be submitted by **Registered Post or Speed Post** in the office of the undersigned from 5.00 PM on dt. 25.02.2021 to 5.00 PM on dt.18.03.2021 during office hours on working days failing which the bid will be rejected. The received original Bid security & Bid cost will be verified at 11.00 AM on 19.03.2021.
- Bids received shall be opened at 11.00 AM on 19.03.2021 in the office of **Block Development Officer, Gurundia** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- Bid documents can be purchased from this office on payment of the cost of bid documents as mentioned against the work in col. 5 in demand draft issued from any Nationalized Scheduled Bank may be prepared in the name of **Block Development Officer, Gurundia payable at SBI, GURUNDIA** towards bid cost .
