It is informed to all concerned that the Odisha State Legal Services Authority has required 4 or 5 eligible persons for their engagement as Other Member in Permanent Lok Adalat (PUS) in Sundargarh District having their proficiency in “**Public Utility Service**” The applicant should be a retired employee having adequate experience and proficiency in “**Public Utility Service**” as defined in **Section 22-A(b) of the Legal Services Authority Act,1987**. Like.

(i) Transport service for the carriage of passengers or goods by air, road or water; or

(ii) Postal, telegraph or telephone service; or

(iii) Supply of power, light or water to the public by any establishment; or

(iv) System of public conservancy or sanitation; or

(v) Service in hospital or dispensary; or

(vi) insurance service, and includes any service which the Central Government or the State Government, as the case may be, may, in the public interest, by notification, declare to be a public utility service for the purposes of this Chapter.

The persons recommended as other member shall hold office for a term of 5 years or till attaining the age of 65 years whichever is earlier.
