WALK-IN-INTERVIEW

A walk-in-interview is scheduled to be held on 29.09.2022 at Govt. (SSD) Higher Secondary School, Tudalaga under Sundargarh District for selection of candidates to be engaged as guest faculties against the existing PGT vacancies for the subjects as mention below:

College of the State shall be engaged without going through the interview process.

The walk-in-interview will commence from 10.AM onwards and the registration of the candidates will start an hour before the commencement of the interview. The interested candidates fulfilling the eligibility criteria as mentioned above may attend the walk-in-interview in the office of the Principal, () on the above-mentioned date and time along with their CV and certificates of educational qualification. Only those candidates having the minimum eligibility criteria as mentioned above will be allowed to attended the interview.

Mode of Selection: The marks will be assigned to the candidates in the following manner and on the basis of the marks secured by the candidates the merit list will be prepared:

B. *Viva – voce* - 40 marks.

- i. Teaching capability 20 marks.
- ii. Conceptual understanding in subject domain 15 marks.
- iii. Perspective in positivity and leadership 05 marks.

Honorarium:- The rate of honorarium to be paid to the guest/visiting faculties to be engaged is Rs. 400/- per class/lecture of 45 minutes duration subject to a maximum ceiling of Rs. 16000/- per month.

Duties and responsibilities:-

1. Guest faculties are required to be engaged for both theory and practical classes.
2. Guest faculties with 3 years of experience may be involved in question setting and evaluation on the recommendation of the Principal, if required. Assignment for question setting would be required for implementing the introduction of compilation of questions bank in each subject. Assignment of evaluation must be implemented after coding of answer paper is fully implemented.

Terms and conditions:- The candidates who would be selected as guest faculties shall work subject to the following terms and conditions:

- a. Guest faculty engaged would have no claim or right for appointment on regular basis nor will they be part of the cadre of teachers of SSD Higher Secondary Schools.
- b. There shall not be any upper limit in taking number of classes but the remuneration per month shall not exceed the Rs. 16000/- per month.
- c. Guest faculty will not be entitled for pay, if remains absent on working day. In case of absence from duty, payment will be calculated on pro rata basis.
- d. Working hours shall be same as other teachers.
- e. The engagement of the guest faculty teachers will automatically come to an end once a regular/contractual teacher is appointed/engaged against the vacant PGT post.
- f. The guest faculty so engaged shall also be entrusted with correction and evaluation work of the concerned subject and he will not be entitled for extra honorarium for such work.

- g. The performance of the teacher will be reviewed on regular basis. If any teacher is found to be non-performing or engaged in activities amounting to misconduct, he/she shall be disengaged by the Principal under intimation to the District Welfare Officer.
- h. Maximum age for guest faculty at the time of application shall be sixty two (62) and the retired teacher engaged as guest faculty under the scheme shall be disengaged on attaining the age of sixty five (65).
- i. Unauthorised absence for a continuous period of 15 days or more will automatically terminate her/his engagement.
