As approved vide Letter No.14701 Dt.27.06.2023 of the Government in Health & Family Welfare Department, Odisha, 120 Posts of Nursing Officer will be filled up in Government Medical College & Hospital, Sundargarh by engaging Retired Government/Private Nursing Personnel. The selection of Retired Nursing Officers will be done as per the guideline issued by the Government in General Administration Department, Odisha vide Resolution No.23750 Dt.27.08.2014 and Office Memorandum No.24533 Dt.29.09.2022 of the Government in Finance Department, Odisha.

Application for engagement of Nursing Officer on consolidated remuneration is invited herewith from the Interested candidates in prescribed format alongwith required documents as in detailed below in hard copy through Regd. Post/Courier/Speed Post only addressed to the **Superintendent, Government Medical College & Hospital, Sundargarh At/PO- Sankara, PS- Town, Sundargarh, Dist-Sundargarh-770020 by 07.08.2023 (5.00 PM)**. Applications received after scheduled date & time will not be accepted.

TERMS & CONDITIONS

1. Nursing Officers who have retired from Government / Private Sector on attaining the age of superannuation and below the age of 65 years having good service records and are physically fit shall be eligible to be considered for re-engagement.
2. The re-engagement is purely temporary and can be terminated at any time by the appointing authority due to unsatisfactory performance of any of the re-engaged Nursing Officer by giving one month notice or till the posts are filled up by regular recruitment. On the contrary, if any re-engaged officer desires to resign he/she shall do so by giving one month written notice to the competent authority.
3. Nursing Officers against whom departmental proceedings or criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.
4. The re-engagement shall be made initially for a period of one year and can be extended for subsequent period of three years with spells of one year each subject to satisfactory performance up to a total period of four years not beyond the age of sixty-five years of age in any case or till the posts are filled up by regular recruitment whichever is earlier.
5. Consolidated remuneration entitled for the posts will be in accordance to the Finance Department Office Memorandum No.24533 dated 29.09.2022.
6. Re-engaged officers shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
