CORRIGENDUM NOTICE

The following changes have been made in the Tender Call Notice No.- 5235/CDM PHO/ SNG Date- 07.09.2020 for supply for erection & installation of Hoarding, flex, banner, poster, wall painting & etc... for RNTCP (NTEP) 2020-21, which are as follows.

1. (a) **Point No- 08 (V).**- Should have an average Annual Turnover of Rs. 50 lakh or more during the last three financial years 2016-2017, 2017-18, 2018-19 as per format annexure-VI.

(b) **Point No- 08 (X).** - Undertaking to be given in Affidavit that the firm has not blacklisted by any Govt. Organisation institution as per format at **Annexure-IV**.

2. **Point No.- 15.-** The Number of hoarding may increase or decrease as per the decision of Technical Committee. Delivery & installation of Hoarding / goods at 17 block CHC/ SDH/ Municipality & Rourkeal Mahanagar as per annexure-01. The installation of hoarding in different Block CHCs should be completed within 45 days from the date of receipt of confirmed purchase order. Any delay by the supplier in the delivery of goods shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part there of subject to a maximum of 10% of purchase order value which will be deducted from the payment due.

3. **Point No.- 16,-** The Assistant Engineer, NHM will be the point person to supervise the installation work. Agency will submit the bill after successful installation of hoardings & the bills should be certified by the Assistant Engineer, NHM, Sundargarh and counter signed by the concerned ADPHO (TB). Full payment will be made after completion of works as per scope of order, subject to the selected agency has to submit the proof of proper installation with certificate duly signed by Head of the Health Institute of Concerned Block CHCs with still photograph of the installed hoarding / flex/ banner/ poster & wall painting from each four site as applicable. Apart from that agency has to submit the GPRS Mapping Photograph of the installed hoarding / banner/ poster & wall painting, if any adverse report submitted by the Assistant Engineer, NHM that must be replaced or re- placed as per the specification set by SIHFW standard within next 10 days time period as mentioned or time period communicated by this office.

The Last date for submission of tender is 05.10.2020 upto 5.00, P.M. & tender shall be opened on 06.10.2020 at 11.30 P.M

All other terms and Conditions remain unchanged.




