

Bids must be accompanied with bid security of the amount specified for the work in the table under Col.3 above in shape of Kissan Vikash Patra / Post Office Savings Bank Account / National Savings Certificate / Postal Office Time Deposit Account / fixed deposit (TDR) from any scheduled Bank pledged in favour of the **DISTRICT FISHERIES OFFICER, SUNDARGARH** Bid security will have to be in any one of the forms as specified in the bidding documents.
5. The bid documents may be purchased from the office of the under signed against a non refundable fee towards cost of documents as indicated in column-4 in shape of cash or demand draft issued from any scheduled bank in favor of the undersigned payable at **SUNDARGARH.**
6. Bid documents requested by mail will be dispatched by registered post / speed post on payment of an extra amount of Rs.500.00 over and above the cost of Bid documents. The authority will not be held responsible for any postal delay in delivery of the document or non-receipt of the same.
7. The bidder shall furnish an affidavit in support of authenticity of documents, relaxation of EMD in case of Engineer Contractor along with the bid. The authority reserves the right to verify the authenticity of documents in case of any doubt of complains.
8. The tender should be mandatory accompanied with the attested Xerox copies of the valid Registration Certificate, valid GST clearance certificate, PAN card, the original money receipt towards purchase of tender documents and other requisite documents as per DTCN. The original certificates of the same only should be produced before the **District Fisheries Officer, Sundargarh** for verification **within 3 (three) days** of opening of the tender, otherwise the Bid shall be considered as non-responsive and thus will be summarily rejected.
9. The Schedule Caste / Scheduled Tribe contractors desire to avail the facility of 10% price preference should enclose the copy of their registration certificate stating fact of the caste by their registration authority with the bid failing which they will not get the price preference as per rule in force.
10. Submission of more than one tender paper by a bidder for a particular work will liable for rejection of all such tender papers.
