



Bids must be accompanied by **Earnest Money deposit / Bid Security** of the amount specified for the work in the table col.4 above in shape of N.S.C/POTD/Post Office Savings Pass Book/ Deposit receipt of any scheduled Bank(valid minimum one year from the date of receipt) pledged in favour of **Block Development Officer, Kuarmunda** and will have to be in any one of the forms as specified in the bidding documents.

The successful bidder will have to submit the **Additional Performance Security** amount as per Works Department OM No.4559 dt.07.05.2021 in shape of T.D.R. will pledged in favour of the **Block Development Officer, Kuarmunda** issued from any Nationalised/ Scheduled Bank in India in original before acceptance of tender, if their quoted amount is less than the estimated cost.
4. The sale of the Bid documents shall start from dt.26/04/2022 at 18:00 hours and close on dt. 07/05/2022 at 13:00 hours. during office hours in the office of the undersigned. Bids shall be received on or before 13:00 hours of 07/05/2022 through Regd. Post or Speed Post only. The authority will not be held responsible for any postal delay in delivering of the bid documents or non-receipt of the same.

The original Bid security along with bid document shall be submitted by **Registered Post or Speed Post** in the office of the undersigned from 10.00 AM on dt. 26/04/2022 to 01.00 PM on dt.07/05/2022 during office hours on working days failing which the bid will be rejected. The received original Bid security & Bid cost will be verified at 11.00 AM on 09/05/2022.
6. Bids received shall be opened at 11.00 AM on 09/05/2022 in the office of **Block Development Officer, Kuarmunda** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

Bid documents can be purchased from this office on payment of the cost of bid documents as mentioned against the work in col. 5 in demand draft issued from any Nationalized Scheduled Bank may be prepared in the name of **Block Development Officer, Kuarmunda payable at SBI, KUARMUNDA** towards bid cost.






