Terms and Condition

- 1) Sale of Tender Paper :-** The prescribed form along-with other documents will be available in the website www.sundargarh.nic.in from **11.00 A.M** to **5.00 P.M** from **04.12.2021 to 18.12.2021(Online)**. The cost of tender papers as mentioned above (Non-refundable) in shape of Bank Draft drawn in favour of Block Development Officer, Lahunipara, Sundargarh in any Nationalized Bank will be submitted alongwith sealed tender paper.
- 2) Date of receipt and mode of submission of tender papers :-** The tenders have to submit in 2nos. of sealed papers (Technical & Financial) in complete shape through Registered Post/Speed Post only, by directly sending to the B.D.O, Lahunipara in his Official Postal address.


The last date of receipt of tender papers is **18.12.2021 (3.30 P.M.)**. The undersigned will not be responsible for postal delay if any or non-receipt of the papers in time. The tenders must super scribe the name of the work project in 2nos. of sealed envelopes.

- 3) **Date of Opening of Tender Paper :-** The tender papers shall be opened on **20.12.2021 at 11.00 A.M. in the Block Meeting Hall, Block Campus, Lahunipara** in the presence of the tenderers or their authorized representatives having written authorization for the purpose and tender committee.
- 4) **Earnest Money Deposit :-** The E.M.D is to be deposited in shape of post office short term deposit/term deposit/N.S.C/KVP/deposit Receipt of any nationalized bank duly pledged in favour of Block Development Officer, Lahunipara as mentioned above.
- 5) **Document to be attached :-** The following document should be furnished with the tender papers failing which tender will be liable to rejection, a) Attested copy of contractor Registration certificate(validation), b) Attested copy of PAN card, GSTIN clearance certificate, Valid Phone No. Email ID, Income tax Clearance. c) Attested copy of labour license, d) Attested copy of Caste Certificate issued by competent authorities in case of S.C/S.T, contractors desirous of availing preference, e) Affidavit as regards the fact of availing award of work without submission of E.M.D/I.S.D during the current financial year in case of Engineer Contractors desirous of availing exemption of E.M.D. The bidder abide by the terms & conditions and complete all the works as estimated in the tender paper.
- 6) If any of the bidder quotes less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and the provision laid down in clause No. 36 of Memorandum No. 12366, dated 08/11/2013 of works Development, Govt. of Odisha will be followed.
- 7) **Additional performance security Deposit :-** Additional performance security shall be deposited by the bidder, where the bid amount is seriously unbalance i.e, less than the estimated cost within 15% in such case/event the bidder will have to deposit the A.P.S.D money i.e **differential cost of the bid amount and the tender value** in shape of Post Office Short term deposit/N.S.C/K.V.P/Deposit receipt of any Nationalized bank duly pledged in favour of the Block Development Officer, Lahunipara, along with tender paper.
- 8) The E.M.D amount will be forfeited, If tenderer backs out from the offer of acceptance of tender, by the competent authority.
- 9) Submission of more than one tender paper by a bidder for single work will be liable for rejection of all such tender papers.
- 10) All kinds of rejected tender paper will not be re-tendered, such tender work will be decided by tender committee.
- 11) If after opening of the Tender, it is seen that, the bid amount will be same then lottery will be held in the same date in presence of the tenderer or their authorized representatives.
- 12) On review of last performance of the work executed through B.D.O, Lahunipara, the lowest-I tender may/may not be considered for the works though he/she becomes lowest-I tenderer.
- 13) As all works are time bound and critical in nature , no extension of time will be allowed. The contract would be closed automatically once time period is lapsed. In this matter no communication will be made with the contractor and penalty will be imposed as per OPWD code.
- 14) The contractors who have failed to execute projects of this agency/backed out from execution process/abandoned the project work midway/house who have been declared by this agency to be defaulters otherwise will not be allowed to participate in the present tender process. If any of such contractors participates then his/her papers will not be considered at all.
- 15) The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.
