

Bids shall be received on or before 16:00 hours of 17.11.2021 through Regd. **Post or Speed Post only**. The original Bid security along with bid document shall be submitted by **Registered Post or Speed Post** in the office of the undersigned from 10AM on dt. 09.11.2021 to 4.00 PM on dt.17.11.2021 during office hours on working days failing which the bid will be rejected. The received original Bid security & Bid cost will be verified at 10.00 AM on 18.11.2021.
6. Bids received shall be opened at 10.00 AM on 18.11.2021 in the office of **Block Development Officer, Kuarmunda** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

Bid documents can be purchased from this office on payment of the cost of bid documents as mentioned against the work in col. 5 in demand draft issued from any Nationalized Scheduled Bank may be prepared in the name of **Block Development Officer, Kuarmunda** payable at SBI, KUARMUNDA towards bid cost .


