- The successful bidder will have to submit the **Additional Performance Security** amount as per Works Department OM No.4559 dt.05.04.2021 in shape of T.D.R. will be pledged in favour of the Block Development Officer, Gurundia issued from any Nationalised/ Scheduled Bank in India in original before acceptance of tender, if their quoted amount is less than the estimated cost.
