The intending tenderer may inspect the vehicles at the garage in the premises of the office of Superintending Engineer, Sundargarh (R&B) Division on any working day after announcement of tender notice.

All the tenders received will be opened in the presence of the tenderer or their authorized agents, at 12.00 Noon **11.04.2022** which if declared a Govt. Holiday the tenders will be opened on the next working day as per the schedule time. Delay in postal delivery shall not be taken into consideration. The tender cover should be super scribed as "**TENDER FOR VEHICLE**".

Tender for vehicle should be submitted in a single cover quoting there bidding price as a hole in rupees. Tender must accompany with the amount of earnest money (EMD) as mentioned against vehicle in shape of Account payee bank draft drawn in favour of the **Superintending Engineer, Sundargarh (R&B) Division**. No tender will be considered valid without payment of the earnest money Bank drafts will be returned to the unsuccessful tenders only after finalization of the tenders.

Tender with highest offer of sale price shall be accepted and such tenderer shall have to deposit 25% of the offered amount of the vehicle on the day of acceptance and balance 75% within seven days of issue of the intimation letter. On failure to make payment as aforesaid deposit (including earnest Money) shall be forfeited.

The vehicle should be removed from the site within seven days from the date depositing the full amount of tendered /negotiated money. Tools, instrument and spare parts shall not be delivered with the vehicle. In case the vehicle(s) is/are not removed, the custody and safety of the vehicles shall be the responsibility of the tenderer and no claim or complain on that account shall be entertained and ground rent at the rate of 1% of tendered/negotiated money will be charged for each day or part of the day till the removal of vehicle from the site.
