4. The sale of the Bid documents shall start from dt.03.12.2021 at 18:00 hours and close on dt. 10.12.2021 at 16:00 hours. during office hours in the office of the undersigned. Bids shall be received on or before 16:00 hours of 10.12.2021 through **Regd. Post or Speed Post only**. The authority will not be held responsible for any postal delay in delivering of the bid documents or non-receipt of the same.

The original Bid security along with bid document shall be submitted by **Registered Post or Speed Post** in the office of the undersigned **from 10:00 AM on dt. 03.12.2021 to 4.00 PM on dt.10.12.2021 during office hours on working days** failing which the bid will be rejected. The received original Bid security & Bid cost will be verified at **11:00 AM on 13.12.2021**.
6. Bids received shall be opened at **11:00 AM on 13.12.2021** in the office of **Block Development Officer, Kuarmunda** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

Bid documents can be purchased from this office on payment of the cost of bid documents as mentioned against the work in col. 5 in demand draft issued from any Nationalized Scheduled Bank may be prepared in the name of **Block Development Officer, Kuarmunda payable at SBI, KUARMUNDA** towards bid cost .




