

- h) The tenderers who are willing to submit their sealed tender should deposit Rs.1000 as Earnest Money Deposit (EMD) in the form of Demand Draft drawn in favour of "Assistant Director of Sericulture, Sundargarh" on any nationalized bank payable at Sundargarh and the same should be enclosed along with the **Tender Form** to the Assistant Director of Sericulture, Sundargarh . No cheque or cash will be accepted and shall be summarily rejected. **EMD can be transferred through RTGS to our official account - State Bank of India A/C no10969167330 and IFSC-SBIN0000189.**
- i) The Earnest Money Deposit of the unsuccessful tenderers will be returned after finalizing the highest bid offered by the merchant, to concerned tenderer, as prompt as possible without any interest and sent to them by post.

Any deviation from the prescribed procedures/required information/formats/conditions shall result in out-right rejection of the Tender.

All documents should be legible, filled in clearly and signed by the authorized representative.

The Tender will be opened on 28.04.2022 at 11.00 A.M. in presence of the authorized representative of the bidder who wish to be present on the spot at that time.

The Tender shall be valid for a period of 90 days from the date of opening of the tender and no request for any variation in quoted rates and /withdrawal of tender on any ground by the bidder shall be entertained. Validity of the bids can be extended on mutual consent.

The bidder having the lowest evaluated tender (L-1) would be considered for award of the order subject to fulfillment of the terms and conditions of the bid documents. In case the lowest bidder ( L-1) is disqualified after selection for any reason, then negotiations will be made with the second lowest ( L-2) bidder for award of contract at L-1 price. However, the decision of the authority shall be final during the overall selection process.

The authority reserves the right to reject any or all tenders and terminate the tender process without assigning any reason thereof.
