**TENDER CALL NOTICE**

Sealed Tenders in enclosed plain prescribed format are invited from the interest persons/ firms/ agencies for sale of the following vehicles of the Regional Transport Authority, Sundargarh on "as is where is" condition, so as to reach the office of the undersigned within 15 days from the date of publication of the tender notice by Regd. Post / Speed Post or by hand to be dropped into the tender box. Separate tender paper shall be used for separate vehicle.

The intending tenderer may inspect the vehicles at the office premises on any working day during office hours within 15 days from the date of publication of the tender notice.

All the tenders received will be opened in the presence of the tenderer or their authorised agents, if present at **04.30 P.M** on **10-05-2022** which if declared a Govt. Holiday the tenders will be opened on the next working day as per the scheduled time. Delay in postal delivery shall not be taken into consideration. The tender cover should be subscribed as "TENDER FOR VEHICLE".

Tender of each vehicle should be submitted separately but may be sent in a single cover. Each tender must accompany with the amount of earnest money. (EMD) of **Rs.5000/-** for each vehicle in shape of **Account Payee bank Draft** drawn in favour of the **R.T.O. Sundargarh payable at SBI, Sundargarh**. No tender will be considered valid without payment of the earnest money. Bank drafts will be returned to the unsuccessful tenders only after finalisation of the tenders.

The tenderer whose offer will be accepted by the Authority shall have to deposit 25% of the offered amount of the vehicle on the day of acceptance and balance 75% within three days of issue of the intimation letter failing which the offer forfeited. The vehicle should be removed from the site within seven days from the date of full payment of the bid amount. Tools, instruments and spare parts shall not be delivered with the vehicle. In case the vehicle(s) is/are not removed, the custody and safety of the vehicle shall be the responsibility of the tenderer and no claim or complain on that account shall be entertained and ground rent @ 1% of tendered/negotiated money will be charged for each day or part of the day till the removal of vehicle from the site.


