The tender fee of Rs. 10,000/- (Non-refundable) by way of Demand Draft should be enclosed along with the tender proposal/paper. The tender paper will be received through Courier/Regd. Post/Speed Post only and should be reach in the office of the undersigned on or before 4/1/2022. The tender will be opened on 5/1/2022 in the presence of the committee members at Conference Hall, RGH.

Terms & Conditions:

1. The tenders should be properly sealed and superscribed as "Tender for Empanelment of Agencies for Orthopaedic Implants for 2021-22 at Rourkela Govt. Hospital".
2. The tenderer shall have to furnish the following documents along with the proposal (Annexure -I)
 - A) Tender processing fee Rs. 10,000/- in favor of Rogi Kalyan Samiti, Rourkela Govt. Hospital.
 - B) Photocopy of the Valid Drug License/Manufacturer Certificate (Wholesalers /Distributor/Dealers) from the competent authority.
 - C) Photocopy of the latest / up-to-date I.T Return & GST payment certificate /receipt.
 - D) Photocopy of the PAN card, GST Registration.
 - E) Proof of supply of orthopedic implants.

3. Preference will be given to:

- A) The Wholesalers /Distributor/Dealer within the Rourkela City .
4. The Wholesalers /Distributor/Dealer shall have stock of all types of orthopaedic implant sets as per demand of Orthopaedic O.T / Department of the Orthopedics.
5. The orthopaedic implant sets of reputed / good brand having lower cost will be preferred. Quoted products shall have CE certificate from respective notified body.

6. The invoice shall be raised in individual i.e by the name & URI no. of the patient.
7. The approved suppliers shall have to supply the orthopaedic implant sets on 24 x 7 bases to meet the emergency.
8. The approved empanelled supplier shall have to execute / supply order in full. In any case the prescribed item(s) are not available with them, then it is the responsibility of the approved supplier(s) to make it available.
9. The approved empanelled supplier(s) shall have to sign MOU with the undersigned before execution of the contract which is valid for one year from the date of signing of MOU or till finalisation of next tender (if desired by the authority).
10. If more than one suppliers are empanelled, in such case purchase will be made on monthly rotation basis.
11. The purchase shall be made on credit basis and the payment will be released as early as possible basing on availability of funds through on line/cheque. At any situation, supply shall not be discontinued / delayed due to late in past payment.
12. If any dispute/irregular supply/cancellation of supply order by the approved supplier(s) will be found during the contract period, no further purchase will be made from the supplier(s) and the supplier(s) shall be blacklisted for 2 years (calendar) from the date of issue of letter. In such case the authority will procure the implants from the bidder offered second highest discount at negotiated highest discounted rate.
13. The tender will be rejected, if the tenderer changes any clause or Annexure of the bid document downloaded from the website.
14. The authority reserves full rights to accept or reject any or all proposals without assigning any reason thereof.
15. In the event of any dispute out of the contract, such dispute should be subject to the Jurisdiction of the Civil Court, Rourkela
16. Each page shall be duly signed and sealed by the bidder.

Selection of Bidder:

Evaluation of bids will be made on the basis of maximum discount offered by the bidder. The base discount is **30% on MRP / bill value**. Hence, the bidder who will offer maximum discount above **30% on MRP** or Total Bill value will be selected as the lowest responsive bidder.

Raising of invoices:

The approved supplier has to raise invoice of the patient, clearly mentioning the URN No. & date and full name of the patient registered & name of the Surgeon of RGH, Rourkela.

The approved supplier has to submit the invoice along with the prescribed and indented orthopedic implant sets to the in-charge person at Orthopedic OT of RGH, Rourkela duly signed & sealed by the Surgeon for further course of actions.
