make the tender liable for rejection. The tender papers should be sent in sealed envelope with the present address for correspondence & Mobile No.

The successful bidders are liable to pay M.V Tax, if any, outstanding against the vehicles as well as GST will be charged extra on the bidding amount. The highest bidder will have to deposit 25% of offered amount against each vehicles on the spot in shape of Draft (In favour of ZSS, Non- NRHM A/c, Sundargarh) or Cash and remaining amount within 7 (Seven)days after issue of the intimation letter, failing which the earnest money amount deposited against the vehicles will be forfeited without any assignment of reasons.

The vehicles will be delivered as is where is basis and the bidders shall remove the vehicles from the site within 7(seven) days from the issue of release order at their own cost. After delivery of the vehicles, the custody and security of the vehicles shall be responsibility of the bidders. No complaint and claimed on this account will be entertained on fellow to remove the vehicles within the aforesaid stipulated period. Ground rent of 1% of the bid amount against each vehicle shall be charged for each day or part of the day till removal of the vehicle from the site. The authority reserves the right to accept/reject any or all the tenders without assigning any reason thereof. No complaint will be accepted after finalization of the tender.
