Tender Call Notice


Sealed tender are invited from interested and reputed Travel Agencies / Tour Operators / Private individuals for providing 1(one) no. of AC **Pertol** driven car Dezere/Amaze/Tigor/City/ Equivalent model of vehicles for DSMS, Sundargarh, having seating capacity not more than six including driver, which shall confirm to the terms & condition (Annexure-II) for official use in DSMS, Sundargarh on monthly rent basis.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for filling of tender. The vehicle should be in good condition as per RTO terms & Conditions.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle. His age should be above 21years.
3. The Driver should be well behaved gentle and obedient in nature.
4. A sum of Rs.5.000/-shall be deposited by the intending bidders in shape of Account Pay Bank draft drawn in favour of the District Supply and Marketing Society (DSMS), Sundargarh and needs to be submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to the unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information(excluding fuel and lubricants)
6. The Vehicle must achieve fuel efficiency of 17 Kms. Per liter.
7. The details of the make and year,of manufacture of the vehicle, registration no., mileage (Kms. Covered per liter) and name of the Driver with Driving License No., and period of validity should be specifically mention in the general bid information to be furnished with the Quotation / tender (Annexure-III)
8. The Quotation completed in all respect should reach the undersigned on or before Dt.08/08/2022 by 3.00 P.M through Registered Post /Speed Post and shall be opened on the same day at 4:30 pm in presence of the bidder or their authorized representatives.



9. The application forms of tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available at District Supply and Marketing society (DSMS) Sundargarh on payment of Rs.100/- (Rupees One Hundred) only from to or can be downloaded from Sundargarh District Website www.sundargarh.nic.in from dt. 25/07/2022 to dt. 08/08/2022. In case, the application form is downloaded from the website, the applicant shall furnish a Demand Draft for an amount of Rs. 100/- (Rupees One Hundred) only, drawn in any Nationalized Bank towards cost of application along with application.
10. The eligible bidder shall commence the service from the date of received the work order and shall continue to provide the service up to one year from the date of the receipt of the work order.





TERMS & CONDITION FOR HIRING OF VEHICLES

1. The following terms & conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.
2. The hired vehicle, during period of contract, shall have all necessary valid MV documents such as: - valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract Carriage Permit, proof of up to date tax payment etc, DL of the driver available all the time. The Department / Office hiring the vehicle shall not be responsible for any damage /loss caused to hired vehicle or loss of life / injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hirer shall not be responsible for all such litigation.
3. The hire charges to be paid after deduction of incomed tax or any other tax as applicable by law on monthly basis is final but does not include cost of petrol / diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear box and differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
4. It shall be the responsibility of the bidderto provide a good driver and the salary of the driver shall be borne by the owner.
5. In case of breakdown of the vehicle for reason whatsoever, the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
6. In case the vehicle dose not report regularly, the authority will be at liberty to reject he agreement and may engage vehicle from other source.
7. The vehicle shall report for a minimum of 26 days in a month.
8. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
9. Monthly hire charges and reimbursement towards cost of petrol / diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills and no advance payment will be made.
10. The vehicle shall not be more than 3 years old from the initial registration and also be in good condition during the period of contract.
11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.



12. In case the bidder / owner intends to withdraw the services of the vehicle and terminate the agreement, it shall be mandatory upon him/her to give one month notice before such withdrawal of services and for termination of agreement.
13. If the bidder violates any of the terms of contract, the entire amount of security deposit shall be forfeited.
