

Sealed quotations are invited from interested reputed Travel Agencies / Tour Operators or private individuals for providing 1 no. of Diesel / Petrol driven vehicle (TUV300 / Bolero / Sumo Gold / Ertiga) having sitting capacity 4 to 5 nos. including driver, which shall confirm to the terms and conditions (Annexure- II) for official use in the Office of the **Additional Chief Engineer, Canal Circle, Burla** on monthly rent basis for the period from **09/2022 to 03/2023**.

1. The vehicle must be in Road Worthy condition, shall not be more that 3 years old from the date of initial registration and must have valid Registration Certificate. Insurance Certificate, Fitness Certificate, valid contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. As per **Works Department, Government of Odisha, Office Memorandum No. 07556900052021(Pt.) - 5984/ dated 27.04.2021**, No Bid Security / Earnest Money Deposit (EMD) has to be deposited and all participating bidder shall submit "**Bid Security Declaration**" as per **Annexure-IV**.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants) in annexure-III.
6. The vehicle must achieve maximum fuel efficiency of 17 Km/litre.
7. The details of the make and year of manufacture of the vehicle, registration no, and name of the driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation (Annexure-III).
8. The Quotation completed in all respect should reach in all the offices where the quotations have been notified to be sold on or before **dt.02.09.2022 up to 05:30 p.m.** and shall be opened on **dt.03.09.2022 at 11:00 a.m.** in presence of the bidders or their authorized representatives willing to be present in the office of the undersigned.
