- 1.1. 1. The sealed tenders super scribed as " TENDER FOR SUPPLY OF DRUGS & CONSUMABLES AND EQUIPMENTS/INSTRUMENTS FOR NPCBVI & SUNETRA PROGRAMME, (DBCS) SUNDARGARH" are to be submitted by Regd. Post/Speed Post/Courier and reach the Office of the Chief District Medical & Public Health Officer, District Blindness Control Society, At: Eye Ward, District Head Quarter Hospital, Po/Dist-Sundargarh, Pin-770001 on 26.09.2022 by 5.30 P.M. The tender received beyond the scheduled date and time will not be entertained under any circumstances. The tender are of double bid system i.e. 1) Technical Bid & 2) Price Bid. The intending tenderer should submit their tenders separately in two sealed covers duly super scribed as Technical Bid & Price Bid putting in a single sealed cover. The tenderer should furnish the Tender Fees Rs. 2000/- (Non Refundable). The Tender Fees will be paid in shape of Bank Draft from any Nationalized Bank in favour of SUNETRA Sundargarh payable at Sundargarh. The bidder shall furnish the bid EMD of Rs 10000 for "SUPPLY OF DRUGS & CONSUMABLES AND EQUIPMENTS/INSTRUMENTS FOR NPCBVI & SUNETRA PROGRAMME, (DBCS) SUNDARGARH" in shape of Demand Draft from any nationalized bank, drawn in favour of "SUNETRA Sundargarh" payable at Sundargarh.
 - 1.1.1. The EMD of successful bidder is liable to be forfeited if the tendered, revokes any terms of the tender within the validity period.
 - 1.1.2. EMDs given by unsuccessful bidders will be refunded after placing of purchase order to the successful bidder.
 - 1.1.3. EMD of the successful bidder will be forfeited in case the successful bidder fails to accept/executes the order.
 - 1.1.4. EMD of successful bidder will be returned after receiving of successful completion of terms & condition of supply certificate of all items. EMD shall not carry any interest.
2. The sealed tenders (Technical Bid) shall be opened by the District Purchase Committee on 27.9.2022 at 12.00 A.M. in presence of either the tenderer or their authorized representatives. If any tenderer their authorized representative fails to turn up at the time of opening of the tenders, the process will continue as usual.
3. All tenderers should give live demonstration of the equipment before the Technical Experts after the bidders have successfully qualified in the Technical Bid.
4. After finalization of the technical bids by the Technical Bid Committee, the price bid of the successful firms who qualify in the specification will be opened by the District Purchase Committee on another date as fixed by the Chief District Medical & Public Health Officer.
5. The tender documents should be clearly written/ typed without any corrections, interpolation and over writings etc and each page of the tender should bear the dated signature of the tenderer.
6. The quoted rates should be in Indian Currency, both in words and figures against each items.
7. The rates so quoted against each item should be F.O.R. designation i.e. to the District Blindness Control Society, Office of the Chief District Medical & Public Health Officer, At/Po/Dist: Sundargarh, Pin-770001, Odisha.
8. The basic rates should be mentioned exclusive of other taxes as admissible and all taxes duties and statutory levies, Entry Taxes, GST/V.A.T. etc should be mentioned separately.
9. The tenderer must should be attached the last performance certificate with the technical bid.
10. The tenderer will be valid for 1 year from the date of approval or till the purchase is over whichever is earlier.
11. The price quoted should be final and shall not be subject to any escalation during the validity of the tender.
12. The tenderer should submit/furnish a certificate in the tender to the effect that price quoted by him/them is not more than the Open Market Price or also not more the rates under of D.G.S. & D, New Delhi where such rates exist. 13. The tenderer will arrange the documents like Customs Clearance Certificate, Customs Duty, Industrial Licenses, N.M.I.C., C.D.E.C. and Letter of Authorization of the Principal firm at their risk and responsibility.
14. The tenderer should submit/furnish detailed literature, brochures, operating manuals and technical details of the instruments along with the tender.
15. The tenderer should mention the brand name of the instruments, country of manufacture, country of shipment and name and address of the Principal firm in their tender along with year of manufacturing.
16. The tenderer should furnish attested Photo copy of the up to date GST clearance certificate as per the Govt. Rules upto **31.07.2022**.
17. The tenderer should furnish valid manufacturing license, Valid ISI and ISO certificate, Valid GMP/WHO GMP certificate, Valid PAN CARD, Proof of annual average turnover certificate.
18. If the manufacturing firms are directly submitting the tender, they should not authorize any agent to quote for the same products simultaneously.
19. Purchase order shall be placed with the successful tenderer and it is obligatory on the part of the selected firm to acknowledge receipt of the purchase order with in fortnight in token of acceptance.
20. The tenderer shall mention the life span of the instrument i.e. minimum two year in technical bid.
21. The installation and demonstration of the instrument shall be done by the successful tenderer at free of cost at the site.
22. The tenderer shall clearly mention about the guarantee period of the equipment i.e. minimum 12 months or more from the date of supply and should provide free service during the said period.
23. The successful tenderers shall replace any part or the entire instruments as may be necessary. If found damaged during transit or during demonstration of the system or if found not confirming to the specification as was approved.
24. The authority, Chief District Medical & Public Health Officer, Sundargarh reserves the right to reject any tender or all tenders in part or full without assigning any reason thereof at any time of the tender process.
25. On receipt of the order for supply of the instruments, the tenderer should execute an agreement after which supply is to be affected within the stipulated date mentioned in the supply/ purchase order i.e. within 15 days of issue of purchase/ supply orders.


