The Tender should be properly sealed and super scribed "Sale of one Ten Wheeler Truck bearing Regd. No. OR-11A-5119, Engine No. and chassis No. are not visible on envelope.

The sealed Tenders will be received by the undersigned on or before 05/11/2022 PM only on working days.

The vehicle can be inspected in the PS premises on any working day during office hours. The Tender will be opened on 14/11/2022 PM in presence of all tenderers or their authorized agents in the office of the undersigned.

The upset price of the vehicle has been fixed to Rs. 90,000/- (Rupees ninety thousands) only.

Each Tender should accompany with a Bank Draft worth Rs. 200/- (Rupees two hundreds) only from any nationalized Bank drawn in favour of IIC, Bhasma PS, Sundargarh as earnest money which will be refunded to the unsuccessful tenderers.

The Tenderers offering highest bid will be required to deposit 25% of the bid amount immediately after the bid and the balance amount shall be deposited in the office of the undersigned within seven days of the confirmation of the tender.

Failure to make a payment as aforesaid, the earnest money so deposited shall be forfeited and the vehicle shall be put to fresh auction.

The Tenderers shall remove the vehicle from the office garage within seven days after making full payment of the bid amount in compliance with the requisite formalities.


Tools, Implements and spare parts shall not be delivered with the vehicle. In case the vehicle is not removed from the office garage within the time limit, and if anything wrong happens to the vehicle, it shall be the responsibility of the tenderers and no claim or complain what so ever on that account shall be entertained.

On failure to remove the vehicle within the time, ground rent @ 1% of the tender money shall be charged for each day or part of the day till removal of the vehicle from the garage.

Where the ground rent so charged exceed the said price deposited by the tenderers, he/she shall cease to have any right on the vehicle.




