

CORRIGENDUM

In partial modification to Tender call notice **No.356 dt. 15-11-2022** Sealed quotations on plain paper are invited from the Local bonafide firms having valid GST Registration No./IT Registration No. for Printing of Form-6B on linking Aadhar data with Electoral Roll data in connection with Special Summary Revision of Photo Electoral Rolls-2023, so as to reach on or before 06-12-2022 at District Election Office, Sundargarh by 01.00 P.M. The quotations will be opened at 5:00 PM of the same date in the Office Chamber of Additional District Magistrate, Sundargarh in presence of the member of Purchase Committee and the bidders or their authorized representatives.

Conditions:

1. The forms should be printed on **A4 size, 60GSM cream wove paper only**.
2. The required quantity of aforesaid form needs to be supplied by the vendor within a week from the date of receipt of the supply order for which the firm should be committed.
3. The rates quoted by the bidders are valid for a period of one year from the date of finalization of the tender.
4. The Purchase Committee reserve the right to reject any or all quotations/ supply order without assigning any reasons thereof. without assigning any reason thereof.
5. The selected vendor has to deposit security money amounting to Rs.20,000/- (Rupees twenty thousand) only in the shape of a Bank draft drawn in favour of the District Election Officer, Sundargarh payable at SBI, Main Branch, Sundargarh
6. In case of failure to supply the required number of forms and quantity in full as per specification within stipulated period the security money will be forfeited and criminal liability as per Election rule will be fixed.
7. Rates should be quoted inclusive of delivery of Form-6B at the District Election Office, Sundargarh also inclusive of charges of taxes as applicable.
8. The sealed envelope for quotation should be captioned as "Tender for Printing of Form-6B" otherwise it will not be taken into account.
