The successful bidder will have to submit the **Additional Performance Security** amount as per Works Department OM No.4559 dt.07.05.2021 in shape of T.D.R. will pledged in favour of the Block Development Officer, Kuarmunda issued from any Nationalised/ Scheduled Bank in India in original before acceptance of tender, if their quoted amount is less than the estimated cost.

Bids shall be received on or before 16:00 hours 09.12.2022 through **Regd. Post or Speed Post only**. The received original Bid security & Bid cost will be verified at **11.00 AM on 12.12.2022**.
6. Bids received shall be opened at **11.00 AM on 12.12.2022** in the office of **Block Development Officer, Kuarmunda** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

Bid documents can be purchased from this office on payment of the cost of bid documents as mentioned against the work in col. 5 in demand draft issued from any Nationalized Scheduled Bank may be prepared in the name of **Block Development Officer, Kuarmunda payable at SBI, KUARMUNDA** towards bid cost .
