### Terms and Conditions

- 1.One local WSHG/ALF can apply for operation and maintenance of one CT/PT only. The WSHG/ALF must be registered in the same ward/area in which CT/PT is present. Priority will be given to the WSHG located near the area where CT/PT is located. Only local WSHG/ALF of Biramitrapur area can apply.
- 2.The Local WSHG/ALF will be responsible for any damage/breakage of any accessory/fixture.
- 3.The Local WSHG/ALF will provide bleaching powder, phenyl, brush, broom stick to the care taker for cleaning of toilet everyday (including provision of all Sanitary Materials).
- 4.The Local WSHG/ALF will pay electricity bill to the electricity provider every month within 5 days from date of receiving the bill. No extra charges towards electricity will be provided by Municipality.
- 5.Minor maintenance will be borne by Local WSHG/ALF.
6. The bill in duplicate must be submitted after approval of competent authority i.e from Sanitation In charge or any other official as decided by office of this Municipality for payment at the end of each month.
- 7.The Sanitary Inspector I/C will be in overall supervision of the CT/PT and the WSHG/ALF will attend any advice after passed by S.I.( I/C).
- 8.The authority reserves the right to reject work order of the selected WSHG/ALF at any time if the work is not found satisfactory.

9. Payment slip of electricity charges of every month shall be submitted by the WSHG/ALF within 7 days of next month along with the bill for payment.
10. Amount will be remitted to the group bank account of WSHG/ALF and no transaction will be made to individual accounts.
11. Selected WSHG/ALF shall ensure that public toilets are opened from 6.00AM to 10.00PM everyday and community toilets are opened 24 Hrs every day.
12. The Selection of WSHG shall be carried out through Lottery System in the Office Chambers Of Executive Officer in the presence of group representative of Local WSHG.
