The quotation shall be received in the office of Additional District Magistrate(General), Sundargarh, sent through **Registered Post** only from 17.02.2023 to 27.02.2023 within the office hour on the working day. The quotation shall be open on dt.28.02.2023 in the chamber of Additional District Magistrate(General), Sundargarh, at 4.00 PM and the quotation shall be finalized by the members of the Committee as approved by the ADM Sundargarh on the same date.

The intending farms may see the specification of erection of hoarding as prescribed by the Department in the office day within the aforesaid date fixed.


1. The rate is to be quoted in plain papers with taxes separately.
2. The materials should be of I.S.I standard.
3. Necessary intimation as to whether the total price of the articles will be inclusive or exclusive of all the taxes (i.e. Sale Tax, VAT, TIN No. GST etc) and other incidental charges if any should be furnished along with the quotations.
4. Copy of VAT clearance certificate and certificate showing the TIN No. of the firm should be enclosed with the quotation.
5. No transportation charges for taking hoarding to different offices shall be borne by the office.
6. The committee reserved the right to accept/reject any quotation basing on the quality and rated of the required materials without assigning any reason thereof.
7. The quotation of the lowest bidder will be acceptable.


