The proof of registration from the appropriate authority shall be enclosed along with the bid.

- 2 Bids must be accompanied by Earnest Money deposit / Bid Security of the amount specified for the work in the table col.4 above in shape of N.S.C/POTD/Post Office Savings Pass Book/ Deposit receipt of any scheduled Bank(valid minimum one year from the date of receipt) pledged in favour of Block Development Officer, Bonaigarh and will have to be in any one of the forms as specified in the bidding documents. Bidders desirous to hire machineries or equipment from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.
(N.B:- EMD in shape of cash / pay orders or Bankers Cheques is not acceptable.)
- 3 The successful bidder will have to submit the Additional Performance Security amount as per Works Department OM No.4559 dt.05.04.2021 in shape of T.D.R. will pledged in favour of the Block Development Officer, Bonaigarh issued from any Nationalized Scheduled Bank in India in original before acceptance of tender, if their quoted amount is less than the estimated cost.
- 4 The sale of the Bid documents shall start from dt. 22/03/2023 at 11.00 AM and close on dt.05/04/2023 at 02.00 PM during office hours in the office of the undersigned. Bids shall be received on or before 02.00 PM of 05/04/2023 through Regd. Post or Speed Post or in Person only. The authority will not be held responsible for any postal delay in delivering of the bid documents or non-receipt of the same.
- 5 The original Bid security along with bid document shall be submitted by Registered Post or Speed Post in Person only in the office of the undersigned from 10.00 AM on dt. 22/03/2023 to 02.00 PM on dt.05/04/2023 during office hours on working days failing which the bid will be rejected. The received original Bid security & Bid cost will be verified at 3.00 PM on 05/04/2023.

- 6 Bids received shall be opened at **3.00 PM on 05/04/2023** in the office of **Block Development Officer, Bonaigarh** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7 Bid documents can be purchased from this office on payment of the cost of bid documents as mentioned against the work in col. 5 in demand draft issued from any Nationalized Scheduled Bank may be prepared in the name of Block Development Officer, Bonaigarh payable at SBI, Bonaigarh towards bid cost .
