TERMS & CONDITION:

- 1-Tender fee of Rs.1500/- (non refundable) should be submitted in shape of DD issued from Nationalised bank in favour of CDM&PHO, Sundargarh.
- 2-The EMD money of Rs.20000/- (refundable) should be submitted in shape of DD issued from Nationalised bank in favour of CDM&PHO, Sundargarh which will be returned after the validity of the tender.
- 3-Copy of valid Authorization Certificate/GSTN registration certificate/ PAN should be submitted with the tender document.
- 4-Preference will be given according to work experience.
- 5-Preference will be given to local agency.
- 6-The cost will be quoted per item/kg.
- 7-Lifting,Transportation,weighting,Labour Charges etc will bear by the bidder.
