

**CORRIGENDUM**

With reference to the RFP No:ZP/SNG/01/2023-24/L.No.1388/ZP, dated: 06.05.2023 towards "Selection of HRSPA on Outsourcing Basis in Sundargarh District" the following few point is to be noted as mentioned below.

1. Under Technical Evaluation (2<sup>nd</sup> Stage), Point No. 1.1 of Clause 9(Evaluation of Proposal), for securing 10 marks it has been mentioned that the average annual turnover of the Agency is to be **INR 50 crores to INR 75** which should be read as **INR 50 crores to INR 75 crores**.
2. Under Technical Evaluation (2<sup>nd</sup> Stage), Point No.3 of Clause 9, the presentation of the concerned Agency participating in the Bidding process should be in Power Point mode limiting to 10-15 minutes only basing on the approach, methodology and work plan to undertake the assignment. Hard Copies of the presentation should also be submitted during the presentation for reference.
3. The non- refundable Bid Proceesing Fees (Tender Cost) of Rs.10,000/- and EMD of Rs.1,00,000/- should be deposited by way of **Demand Draft** only in favour of "CDO-cum-Executive Officer, Zilla Parishad, Sundargarh" and ignore all other mode of deposit.
4. "Selection of Manpower Agency for Providing Manpower through Outsourcing basis in Sundargarh District" mentioned in the RFP is same to be read as "Selection of HRSPA on Outsourcing Basis in Sundargarh District"
5. The date of advertisement for engagement of HRSPA published in Daily Newspaper "The SAMAJ" has been mentioned as 6<sup>th</sup> June, 2023, which may be treated as 6<sup>th</sup> May, 2023.
6. At Clause No.9 under Technical Evaluation, it is clarified that the Bidders who will secure minimum 70 marks out of 100 Marks under Technical Proposal will be called for financial evaluation.
7. Under Tech-2 , E.P.F & E.S.I Nos. should be supported with self-attested copy of the registration certificate along with latest deposit challan copy of the same by the Bidder.

All other terms and condition of the RFP including last date of receipt of bid, mode of receipt of bid & date/time of opening of the bid remains unchanged.
