With reference to the RFP No:ZP/SNG/01/2023-24/L.No.1388/ZP, dated: 06.05.2023 towards "Selection of HRSPA on Outsourcing Basis in Sundargarh District" the following Corrigendum is issued for better competition in the process;

Clause-1 Pre-qualification Criteria:

It has been mentioned that the minimum average annual turn over of the bidder for last three FY (2019-20,2020-21 and 2021-22) was minimum INR 50.00 crore, which has been relaxed to INR 25.00 crore.

Clause-9 of RFP(Evaluation of Proposal) Technical Evaluation 2nd Stage:

The Bidder's average annual turnover in India in the last three financial years ending 31st March 2022 which was fixed to minimum INR 50 Crores or above is revised to INR 25 Crores or above. :

The Scoring Criteria is also revised accordingly as follows;

- INR 25 crores to INR 50 crores = 10 Marks
- INR 50 crores to INR 75 crores = 15 Marks
- INR 75 crores and above = 20 Marks
