**TERMS AND CONDITION FOR AUCTION SALE OF GOVERNMENT JEEP
REGISTRATION NO: OR-14-B-4180 (Mahindra & Mahindra) OF ICDS PROJECT,
LAHUNIPARA**

1. Government jeep bearing Registration No: OR-14-B-4180 of ICDS Project, Lahunipara is being put to auction sale on the basis of inspection report of the concerned office jeep Letter No-571/ Date:19.01.2019 of Inspector of Motor Vehicle, O.M.V.D, Rourkela and Memo No-10858/WCDMS, Dated: 30.07.2019 of Director, ICDS & SW.
2. The above vehicle may be inspected by the intending tender during the office hours in the Office of CDPO, Lahunipara w.e.f. 05.08.2023 to 19.08.2023.
3. The tender received after due date and time will not be accepted and no complaint will be entertained after closure of the tender.
4. The tender should be furnished clearly mentioning with actual sale price proposed to offer for the auction sale of the jeep both in figure and words without any cutting or overwriting.
5. Tender should write in the capital letter on the top of the sealed envelope " TENDER PAPER FOR AUCTION SALE OF ICDS OFFICE JEEP".
6. The tender shall accompany with the earnest money of Rs. 1,000/- (Rupees one thousand) only in shape of Bank Draft drawn in favour of Child Development Project Officer, ICDS Project, Lahunipara payable at State Bank of India, Lahunipara.
7. Sealed tender paper should be sent only by Speed Post/ Regd. Post to Child Development Project Officer, ICDS project, Lahunipara, Dist- Sundargarh.
8. The E.M.D of Rs. 1,000/- will be refunded to the tenderers whose tenders are accepted except in case of highest bidder.
9. The highest tender in whose favour tender is accepted shall have to deposit 25% of the sale price in shape of Bank Draft drawn in favour of Child Development Project Officer, ICDS project, Lahunipara payable at State Bank of India, Lahunipara within two (02) days excluding E.M.D and execute necessary agreement.
10. In case of failure to deposit 25% of sale value, the vehicle will be put to resale immediately after completion of 02 (two) days with allowing the defaulting tender to participate in the tender sale and his E.M.D will be forfeited to Government.
11. The shortfall in Government Revenue on account of subsequent sale, if any shall be recovered from him. The highest tender in whose favour the sale is approved shall have to deposit balance 75% of the sale price of the vehicle within 07 (seven) days of receipt of rectification order from the competent authority and E.M.D amount deposited by him shall be adjusted towards sale of value.
12. In case of failure to deposit balance 75% of sale price of the vehicle within scheduled time, the E.M.D and 25% of the sale value deposited by the highest bidder shall be forfeited to Government and the vehicle will be put to resale at the risk of the defaulting tender.
13. The vehicle shall not be delivered to the tenderer until full payment is made and requisite formalities are completed.

14. Tools, implements and spare parts shall not be delivered with the vehicle. Any shortfall in the resale saves to be deposited by the defaulting bidder from him as arrears of land revenue. However, the tenderer shall not be entitled for any excess amount received in the resale.
15. The successful tender shall have removed the vehicle within 07(seven) days of full payment. There after custodian, safe guard of the vehicle shall be responsibility of the tender and no claim or complain on that account shall be entertained. Failure to remove the vehicle within the stipulated period shall invite necessary ground rate @ 1% of the tender money for each day or part of their day till removal of the vehicle. However, after 30 days from the date of full payment in case of non removal of the vehicle from the site, the vehicle including sale price/ E.M.D deposited by the tender shall be forfeited to Government and no claim will be entertained.
16. All the letter shall be issued to the highest tenderer to the address furnished by him in the agreement form, any dispute arising shall be settled within the jurisdiction of Lahunipara Block.
