Madam/Sir,

I am directed to invite a reference to the subject mentioned above and to say that with the declaration of schedule for the General Elections to Lok Sabha and Odisha Vidhan Sabha by the Election Commission of India on 16.03.2024, the Model Code of Conduct (MCC) have come into force with immediate effect and will be in force till the completion of General Elections and simultaneous Assembly Elections, 2024.

It is, therefore, directed that the joint hearing of Monday Public Grievances by the Collector & DMs along with the SPs of the districts have been adjourned till the end of the election process.
