EXPRESSIONS OF INETREST (EOI)

Eol for aggregator/ Buyer/ Recycler of Solid Waste including Plastic (Recyclable and Non-recyclable waste) from District level Plastic Waste Management Unit at Kuarmunda Panchayat Samiti (Sundargarh)

The district-level PWM Unit, Kuarmunda Panchayat Samiti invites expressions of interest (Eol) for the agencies or vendors for the purchase of different types of solid waste, including plastic waste (both recyclable and non-recyclable). In the PWM Unit, various types of solid waste are managed, including different types of **plastics, glass materials, metals, electronic waste, paper, and textile waste (cloths)**. The unit is equipped with machinery for **baling, shredding, and air blowing**, which can be used as needed. Eol are open for three categories (item-wise), agencies can participate in each category according to their operational capacities.

INSTRUCTION & GENERAL TERMS AND CONDITIONS:

Interested agencies are requested to read all the Guidelines/Criteria carefully and submit their Expression of Interest (Eol) request on their letterhead as per the prescribed format and guidelines/criteria provided in the EOI document(**Annexure-I**). The Eol document should be sealed and addressed to the Block Development Officer, Kuarmunda, with the mention of **"Eol for Aggregator/Buyer/Recycler of Solid Waste including Plastic (Recyclable and Non-recyclable) from the district-level Plastic Waste Management Unit at Kuarmunda Panchayat Samiti (Sundargarh)."**

The base rate for each category and sub-category is provided in Annexure-II.

DATE, TIME & PLACE FOR SUBMITTING THE EXPRESSION OF INETREST (EOI) :

Bid documents consisting of specifications/category/subcategory of materials and the set of terms and conditions of contract and other necessary documents can be seen in the office of the undersigned during office hours every day except on Sunday and public holidays till last date of sale and receipt of the bid. 


